# It's all planned; duh!

# Introduction

Society is divided regarding current affairs. There are those who believe everything is normal; that social problems are the result of political incompetence and graft; that there is no over-arching power above governments. Then there are those who believe that there is a global Elite cabal that dominates national governments. That globalist agendas are behind all government policies and that a relatively few people control the world in submission to Satan. In short, current events are planned to comply with Elite agendas.

This is typified by the constant debate between two commentator friends: Toby Young (founder of the Free Speech Union) and James Delingpole (host of the Delingpod). Their disagreements are aired on the podcast London Calling. Young attributes everything to political incompetence; Delingpole has travelled deeper into what are derisively called 'conspiracy theories' over the last three years and believes that everything is planned.

Young expressed his views claiming that the release of the Matt Hancock Whatsapp messages by Isabel Oakeshott shows that the Covid policy reactions were the result of incompetence and political expediency. He stated that this proved his thesis was correct. He clearly didn't notice that one message by Hancock stated that Bill Gates owed him one since he had injected one of his chips into millions of people.

Much as I admire Young for his tireless work defending free speech, he is wrong. I wrote a piece discussing some aspects of this debate in a paper called '*Cui Bono*'. Here I want to explain why what's happening to society is following specific plans that can be accessed and examined. **It IS all planned**; and that is unequivocal because the plans are extant.

One of the best examples of planning over many years that was later fulfilled to the letter of those plans was the Covid crisis. This is why so many people are waking up to what is going on and seeing the measure of control by small groups of Elite forces. Every member of the population was affected by insane governmental actions, later proved to be useless, artificial and damaging, but were all planned in advance by Elite bodies; which I will prove.

So, in this paper I will explain a few damaging items that are affecting us today, or did affect us all recently, showing that the plans for these went back years or decades. The Covid response is a key issue. I will then reveal a list of specific planning events, reports, presentations and speeches that led to later societal changes. The negative social engineering going on today is not an accident; it is the result of planned changes agreed by a small coterie of men who seek to rule the world.

# The excess deaths since the vaccine roll out

Is it coincidental that a Club of Rome document, *Limits to Growth*, produced in 1972, and its corollary documentary in 1973, indicated that there would be a spike in the death rate in 2023 onwards?<sup>1</sup> The world crisis would begin in 2020 and get worse. How did they know?<sup>2</sup>

Is it coincidental that a UN Agenda 2021 report from the Rio conference in 1992 stated that the period from 2020 to 2026 was called 'the killing years'? After an outcry this section was removed from the UN website but hard copies must be around somewhere.

Is it merely incompetence that governments coerced populations into taking mRNA vaccines when the Pfizer trial documentation available to them already showed that they caused serious injury and death? In fact there were more deaths in the vaccinated cohort than the unvaccinated.<sup>3</sup> Is it further incompetence that the post-marketing trial data supplied by Pfizer showed massive adverse reactions including serious injuries and deaths? This was known to the government in early 2021 but the rollout was still coerced.<sup>4</sup>

Is it coincidence that the world is experiencing huge excess deaths statistics since the vaccine rollout?

# The Covid 'pandemic'

This was prefigured in multiple documents, spreadsheets, tabletop exercises and simulations going back 20 years or more. These include: Event 201, the Crimson Contagion report, the John's Hopkins SPARS document, the Rockefeller 'Lock-step' report and many more.

These proposed various responses to the pandemic which were novel and never used globally before, including: lockdown of whole healthy populations, universal facemask wearing, social distancing, vaccine mandates, vaccine digital IDs, and furlough schemes.

Thus we have all of the world's nations, apparently independently, all initiating the same unusual responses all at the same time. How can that be accidental or incompetence? Not only were the same odd and stupid measures established globally, the very same phrases were used by politicians to justify them: 'three weeks to flatten the curve', 'save the NHS', 'don't kill your grandmother', 'if you venture outside you can kill people', 'a great reset', 'build back better', etc.

This is very evidently a concerted response to a fake pandemic. All nations followed the same plan to the letter.

Why are there patents regarding all aspects of the novel coronavirus going back 20 years? How is it that patents of the Covid vaccine go back several years? Why was Moderna working on a Covid vaccine in 2017 and Pfizer just before the pandemic was announced by the WHO?

There was a plan.

# Climate Change alarmism

This began as an initiative discussed in 1956 by The Rockefeller Brothers Fund. It then became a chief Rockefeller plan for developing a new world order, notably promoted by Maurice Strong. This became codified in publications by the Elite group The Club of Rome, notably after 1972. It began to take formal shape in the creation of the UN's IPCC in 1988, which was then ratified by the 1992 Rio Earth Summit and codified in the subsequent

Agenda 2021 (later 2030). All the subsequent developments (e.g. the WEF's Great Reset) stem from this.

15-Minute Cities or SMART Cities or 20-Minute Cities

# 15-minute cities

These are spreading all over the globe with the most contentious currently being the plan to zone Oxford next year. They are also known as 'SMART Cities' and '20-minute cities'.

This attack on liberty and mobility is entirely novel; nothing like this has been seen before to such a degree. Did it appear from nowhere? Is it a rational response to the Net-Zero agenda? In actuality these zones are climate lockdowns.

For example; Oxford council claims that the purpose is to diminish vehicle congestion and hasten bus travel. However, its commissioned report on these issues (which was withheld from public view before the consultation period ended) has categorically stated that vehicle congestion will increase, on some roads by over 60%, and that bus travel will not change. The measures have nothing to do with easing congestion but have another purpose.

Low Traffic Neighbourhoods (LTNs)

In conjunction with proposed 15-minute cities there is also the existing problem, recently introduced, of LTNs. This is where certain roads in a town are barricaded off by planters or concrete blocks. One example is Oxford. The claim is that this is easing pollution and congestion (why, when the same cars go on longer journeys around the roadblock). Within weeks of deploying these barricades there were reports of 240 ambulances being delayed (including those responding to cardiac arrests).

In anger over this, local residents are already burning down wooden planters and destroying the adjacent CCTV cameras.

Even a fool can spot that this is merely establishing a new control system on local populations and discouraging car travel.

In fact the sources of this strategy are multiple plans by the global Elite going back decades. More recently, the WEF has published papers on the need to introduce patrolled zones in cities and restrict human movements, especially in cars.<sup>5</sup> The C40 Cities document<sup>6</sup> (see later) also demands these to meet climate agendas.

But there are measures in the UN's Agenda 2021 (now Agenda 2030) that go back to 1992 and were signed off by virtually all nations demanding similar zoning. The 15-minute (sometimes 20-minute) city idea is a part of a plan to restrict people from travelling freely and to keep people locked in local zones. This enables greater authoritarian surveillance and control of populations. This document also refers to the importance of the agenda being rolled out at regional and city level, not just national levels.

Even further back are the 1956 original plans of the Rockefeller Brothers Fund (see later) to use climate alarmism to bring about control of global resources and social engineering.

# Killing off farming

There are currently measures to destroy farming in many nations, especially the US, the UK and The Netherlands. Holland seeks to eradicate 90% of the most productive farms in the whole world – which will create fruit and vegetable shortages worldwide.

This is merely part of a plan to rewild rural areas that will be devoid of human beings – who will be forced into cramped megalopolis cities. Only federal agents and the military will have access to the countryside. Huge urban ghettos will be linked by single highways traversing the countryside.

This is a key aspect of Agenda 2021 going back to 1992.

# The fragmentation of society into victim groups

Society has been fragmented over many years into multiple victim groups claiming special status. Government policies and laws have granted special status to many of these groups to the confusion and detriment of wider society. The groups/issues include: homosexuals (Gay Rights, hate laws), Third Wave Feminism (women's rights), Transgender issues (Trans rights), Black Lives Matter issues (Critical Race Theory, quota systems, hate laws), Islamophobia, Intersectionality and so on.

These divide society and create a breeding ground for resentment, anxiety, civil disturbances and eventually civil war.

Now all of this was planned. It was planned by the Cultural Marxists going back to the anthropologists in the Frankfurt School of the 1930s, with the premise going back further to Gramsci in the early 20<sup>th</sup> century. I explain all of this in my paper 'Cultural Marxism'. The Cultural Marxists seek to destroy Western Christian-based societies and foment an internal social revolution as a result of occupying all the key positions in society by stealth ('the long march through the institutions').

# The present and continuing food crisis

How is it that the aforementioned Club of Rome document exactly predicted that a food crisis would develop in 2023 onwards?

How did the 1992 Rio Summit conclude that there would be a food crisis in the early 2020s or that food supply chains would collapse?

Why did the British government stack up on emergency food rations and store them in 2022?

How did the Rockefeller Lock Step presentation know that food supply chains would break down after a coronavirus pandemic?

The artificial Environmental, Social and Governance metric, supposedly based on promoting sustainability

**ESG** 

The artificial Environmental, Social and Governance metric, supposedly based on promoting sustainability, is controlling and damaging businesses. It seeks to punish businesses that are not complying with sustainability projects in their mission. The decisions are arbitrary and biased. For example, Tesla (Elon Musk who has confronted the

Elite cabal) has had a negative ESG score, despite producing 'sustainable' electric cars, while Exxon received a positive score, despite producing petrochemical fuels.

The root of this nonsense lies in the Agenda 2021 sustainability goals and reinforced by the WEF's ESG programme outlined in The Great Reset.

# **Technocracy**

The goals of Technocracy are now dominating the West and these are linking in to every aspect of social life. We can list the basis of Technocracy as:

- The development of multiple types of Artificial Intelligence programmes (AI).
- Algorithms forming the basis of digital functioning. Lack of personal business contact.
- Gene editing forming the basis of medical and social programmes.
- Advanced robotics being used in multiple business and military programmes...
- Transhumanism. Joining humans to digital platforms. Personal digital surveillance through injected circuits in vaccines.
- SMART technology being used in every area of life.
- Internet of Things. The connectivity through SMART devices of appliances to a central control base.
- Internet of Bodies. The connectivity of humans through digital processes to a central control base.
- Central Bank Digital Currency. This, combined with a social credit system, gives the global Elite complete control over populations.
- Connectivity of everything.

All of this was spoken about in Elite circles going back many decades but it was openly articulated by the WEF in 2015 in its programme, *The Fourth Industrial Revolution*.

The plans for social control over populations was outlined in the principles of Technocracy proposed by various bodies going back to the 1930s; such as the Technocracy Movement developed by Howard Scott.

In 2013 an EU briefing stated that the EU Commission was a 'technocratic authority'. This is a prototype of an unelected, unrepresentative body controlling a federal empire. This is a model for the proposed future global government which will also be autocratic, unelected, despotic and founded on Technocracy. This is because Technocracy enables complete governmental control over people through the multiple digital technologies that they require for survival in the world (e.g. banking). These can be terminated by the flick of a switch and lives halted. This cannot be done in an analogue system.

# The collapse of society

The collapse of society, in all areas, is not an accident; it was planned from over 100 years ago and implemented by degrees.

# The collapse of education

Rockefeller developed plans for the control of education after 1908. This initially focused upon the control of history subjects so that pupils could not develop a broad understanding of world history. As in medicine, it was achieved by using money to finance institutions and put loyal placemen in positions of authority on university / school boards. This has led to the situation today where almost nothing is taught about history except the Second World War with a focus on the Holocaust.

# The collapse of medical care

Rockefeller began to develop the idea of Allopathic medicine and eradicating natural medicine in 1901 but in 1910 this was pushed into overdrive by the publication of the Flexner Report [see later].

# The collapse of nation states through multiculturalism

This began with the Kalergi Plan to mongrelise Europe through mass immigration of Asians and Africans and create a hegemony under Jewish control [see later].

# The collapse of social integration

Social integration had developed slowly over centuries based upon shared beliefs. Foremost among these were the principles of Biblical Christianity, which had been central to social life since the time of the Celts. Christian principles ensured a harmonious society (as far as possible) because it commands that every person does good to every other person in the fear of God. This led to laws based upon God's law to punish evildoers and promote social welfare.

The destruction of these principles was a planned strategy involving many Elite groups, but especially the Cultural Marxists. They understood that social cohesion rested upon Christian principles and thus sought to destroy those principles in every aspect of culture Their strategy was to create dis-harmony, confusion, disheartenment, and hatred by empowering marginalised social groups fighting others, especially White privileged British men.

# The collapse of religion

Destroying religion, especially Christian denominations, was essential in order to destroy British society. Thus a policy was determined going back over 100 years to infiltrate, subvert and wreck Christian churches from within by stealth (a Trojan Horse). This was a multi-pronged attack involving a series of policies including: heresy promotion, practical aberrations, mysticism, emotionalism, paganism, occultism, unorthodox popular movements, bad translations of the Bible, compromised church leaders and so on.

When a large church uses a bad Bible translation and has a compromised leader who introduces heresies and aberrations, then hundreds of people are led astray, who then lead hundreds more astray. Before long, most of the church is compromised and deceived. At that point the deception becomes even more intense leading to completely irrational behaviour. This was exampled in the Toronto Blessing insanity, which dominated the world for a few years.

# Collapse of integral institutions

This would include state and local government, the judiciary, the police force, the magistracy, the secret services, and the armed forces.

All of these groups have been corrupted from within over a period of time. This has been done by a number of factors including Cultural Marxism, Common Purpose, Chatham House, Fabianism, pressure from bankers, and others.

For example, the current crisis affecting the Metropolitan Police force, which is officially being described as misogynist, racist, homophobic and corrupt, was dominated by a Common Purpose chief (Cressida Dick) for many years and corrupted from within.

I doubt that anyone disagrees that institutions are now seriously corrupt. Even mainstream journalist Peter Hitchens has openly called for the abolition of the police force. Everyone is aware of the serious degrading of justice whereby victims are abused and criminals are

treated leniently. The police are so busy policing social media hate incidents (recording them illegally as 'non-crime hate incidents' and giving someone a police record) that they cannot investigate real crimes like burglary, car theft, and minor violent incidents. They don't even turn up but merely give a crime number for insurance purposes. The level of successful detective investigations today is a tiny fraction of what it was in Victorian times.

As for political parties; they have become a joke and completely superfluous. There isn't a cigarette paper between the Right and Left. During Covid the opposition party fully supported the implementation of martial law over the whole of society by a Conservative executive without debate. Since 2010 the Conservative party has become a Socialist party. David Cameron boasted that his greatest achievement was the introduction of Gay marriage; how is that Conservative?

All the institutions are broken; destroyed from within according to the plans laid out by Cultural Marxists in the 1930s.

# De-humanism

The essence of totalitarian regimes is an elite group in control over a despised, dehumanised slave population. If the slaves were not de-humanised they would not be slaves.

The elite people in global control all have an ideology that assures them that they are privileged and that the rest of humanity are cattle, only fit to be slaves. This would include Talmudic Jews, Freemasons, Kabbalists, Sabbateans, Gnostics, Theosophists and occultists.

The current global Elite agenda is based upon creating a slave population and multiple measures are being initiated to de-humanise human populations. These include: restricting mobility, destroying the family, making people eat insects, encouraging cannibalism, preventing people from normal family relationships (as in lockdowns), social engineering projects (e.g. Intersectionalism), facemasks, social distancing, controlling finances (as in CBDCs), creating inflation (i.e. creating poverty), creating irrational social constructs (e.g. Transgenderism), constant surveillance and many more.

But these de-humanising projects were planned in previous decades. In the 1970s the Club of Rome identified human beings as the source of the planet's problems: 'The common enemy of humanity is man', (The First Global Revolution, p115). The Club of Rome's idea of Green sustainability global necessities would be used as a foil for social engineering and Fascist control. This was codified in the 1992 UN Eco Summit and Agenda 2021 which proposed limiting humans into huge megalopolis cities and restricting nature from everyone but the Elite. Green sustainability policies would lead to complete authoritarian control over all people.

This was further codified in the policies of the WEF, which was openly opposed to humans outside of the Elite: 'What do we need humans for, or at least why do we need so many humans. We just don't need the vast majority of the population. [Technology] will make [people] redundant and will make it possible to replace the people', (Yuval Noah Harari, WEF advisor). In addition the WEF is intent on Transhumanism: changing what it means to be human by altering DNA through vaccines and making humans into cyborgs with internal computer chips inserted through vaccines. This is not a conspiracy theory; it is underway already.

The Covid vaccines have already permanently changed the DNA of recipients and also inserted graphene structures into the bloodstream, which self-assemble into circuits and antennae. External devices, such as a mobile 'phone, now register vaccinated people as a Wi-Fi (MAC) address.<sup>8</sup> The plans and patents for these vaccines to implement human engineering go back to the 1990s (see later).

So the whole de-humanisation and Transhumanism projects go back decades and were completely planned.

# Measures to enforce final complete control

#### ΑI

This secures complete management control without human intervention. AI systems using algorithms will manage the whole system of operation. Already AI apps in the public domain are amazing people at their ability to function in seconds. ChatGPT can write a complex essay on esoteric subjects set to given parameters in three seconds. You can bet that the Elite have much higher functionality AI already.

#### **Robotics**

Advanced robotics and androids will do most of the jobs that are currently performed by people. Already robots can mimic a human being. This will make most of humanity redundant.

#### **CBDCs**

This gives the Elite complete personal control by remotely, without any human intervention, determining whether you can utilise your own money or not.

There will be restrictions based on climate alarmism and other nonsense that will set parameters for your spending. For example:

- You travelled more then 15 miles today, you cannot use your account for 24 hours.
- You ate more than your allotted sustainability amount, therefore, your account is temporality closed.
- You accessed a forbidden website promoting misinformation; your account is closed.
- You have not renewed your TV licence, therefore, your account is closed.
- You offended a Transgender person; your account is closed.
- You have not had the latest vaccine your account is closed.

This is a literal fulfilment of Revelation's warning that the end-time totalitarian state would control buying and selling.

# Complete surveillance

Everyone will be surveilled 24-hours a day, every day. This will be done as part of the Internet of Bodies using 5G telecommunications. The surveillance will use internal digital nano-chips that are being imparted in the Covid booster shots to create operating systems within the body.

Everything you own, all your devices and appliances, will be surveilled as part of the Internet of Things. Many appliances are already fitted with a computer chip to report data. Thus appliances could be shut down if you breach Elite conditions.

Note that the government is about to demand that everyone fits a SMART electric meter (despite the fact that they pose a serious health risk). Thus your electricity could be shut down if you do not comply with government policy in some area.

CCTV cameras, already installed everywhere, now have facial recognition capability. Not only are you constantly monitored within your home (this is already happening through SMART TV, Alexa and other devices) but you are also monitored as you travel about town, enter shops, work in an office etc.

# Social credit systems

These are already in operation in China. Your social behaviour is checked against a government template and penalties are given if you fail. For example, you lose credit (and thus money) if you jaywalked.

#### **UBI**

Universal Basic Income. Gradually all wages will be replaced by UBI. Everyone will then be reliant upon government handouts and forced into a restricted life according to government diktats.

UBI will be tied in to social credit. Break the social credit rules and you will be docked wages.

#### 15-minute SMART cities

These are currently being rolled out worldwide, such as in Oxford.

This initially controls zones of a city where there is supposed to be all necessary amenities within a five minute walk or cycle ride. It intends to restrict car movements. Driving between zones is forbidden (above a limited allotment), sanctioned by a fine. At the moment cars will be forced to go out to circular road systems and back into the chosen zone thus creating more CO2 and pollution – despite the claim that the idea is to ease

congestion and lessen pollution. Eventually, it will be complete restrictions with no allowances.

The purpose is 'ghettoisation'; limiting people into cells or zones and preventing mobility.

This is the beginning of the concentration of people into intense urban areas (a megalopolis) and the forbidding of access to rural areas.

#### **Food restrictions**

In the name of climate alarmism, certain foods will be off the menu. This will chiefly include all meat products – to be replaced by insects or synthetic lab-created meat.

Eggs will also be targeted. NB that you can live on one egg per day. Good nourishment will be denied to people. Synthetic eggs will be provided and are already being made in China.

Locally grown food, such as back garden produce, will be outlawed. NB the current government plan to register home garden food produce.

Vitamin and mineral supplements will also be forbidden. They are already being restricted within the EU.

# Censorship

Based on claims of misinformation and disinformation, laws will be passed to prevent people from accessing certain websites. Measures will be taken to shut down dissenting websites. Only sites complying with government policy will be allowed. Note that this is already being applied by NGOs and social media platforms.

Under social credit policies, personal access to the Internet can be shut down completely as a penalty of non-compliance.

# The Long Term NHS Plan

This is basically the termination of free health care at the point of delivery.

There are multiple aspects to this plan (see NHS website) but they include:

- Removal of GPs and surgeries.
- Drugs to be prescribed and conditions diagnosed by a pharmacist.
- Hospitals to only allow five conditions for treatment, such as anaphylaxis, sepsis, pneumonia and cardiac arrest.
- Consultancy clinics to be performed remotely by zoom.
- Most treatment to be provided in the local community (a hub) or at home.
- Personal budgets to be set to limit treatments.
- Removal of the ambulance service, in the main.

The evidence for all these things is found in the documents that I describe in the following pages.

# Historic factors in the development of plans for total social control

#### 1770: Protocols of the Elders of Zion

The principles laid out in this debated document necessitate inclusion because they have been worked out in history virtually to the letter. I have books alleging that the published Russian document is a forgery and books claiming that they are minutes of a Rothschild meeting with later additions. Whatever your view, the principles need examination because they were achieved.

What is un-debatable is that the strategies have been enacted exactly in later history; the policies were confirmed as achieved by Harold Wallace Rosenthal in 1976 and Dr Richard Day in 1969 [see later].

In <u>1770</u> Rothschild employed Adam Weishaupt to revise and modernise the age-old 'protocols' – the elite's plans for world domination and the creation of a Luciferian society by subversion.

Weishaupt completed the revised protocols in May 1776. The essence of the plans were as follows:

- Destruction of all national governments.
- Destruction of all religions.
- Establishment of Luciferianism.
- Abolition of the family.
- Abolition of private property (Socialism).
- Divide the masses ('goyim', i.e. 'human cattle', a term used by Jews for Gentiles) into opposing camps, dividing them on politics, race, social, and economic issues.
- Arm the opposing sides and create incidents to cause them to fight and weaken themselves until they destroyed the nation and the religion. [The First World War is a classic example of this.]
- Use money and sex to bribe high-level people already in all national seats of power and influence. Then hold these people in bondage by blackmail or threats of ruin and harm to family. Many British politicians are being blackmailed by evidence of paedophilia.<sup>9</sup>
- Place Illuminati stooges in positions in colleges and universities to recommend exceptional students from well-bred families to be international agents. Scholarships would be given to those selected. These would later be used as advisors behind the scenes in government.
- Control the press and all media. Use the news as propaganda for the elite's strategies.
- Foment colonial wars to weaken the then dominant empires of Britain and France, beginning in 1789.

Weishaupt then organised the Illuminati to execute this plan. Using deception, he recruited about 2,000 eminent followers in the worlds of art, education, science, finance and industry. He then created the Lodges of the Grand Orient to be a secret headquarters.

The principles were discovered by accident and the Bavarian government ordered a raid on Weishaupt's lodges and some of his followers, including a baron, were arrested. Additional documents seized proved to them that there was an international conspiracy.

In 1785 the British government outlawed the Illuminati and closed the Lodges of the Grand Orient. In 1786 they published their findings about the conspiracy in 'The Original Writings of the Order and Sect of the Illuminati'. Yet this warning was ignored and the Illuminati went underground.

The Protocols later appeared widely in Europe in 1905 based on a manuscript held by the Russians. It was first published in Russia by Prof. Sergius A Nilus in 1901 within his book 'The Great Within the Small'. Elite media claims they are copied from an 1864 book by Maurice Joly¹o or another by Jacob Venedey in 1850.¹¹ Yet others affirm that they were adapted from an 1864 satire on Napoleon III's authoritarian regime.

Other sources say that the refutations of the Protocols being a forgery are false, being Zionist disinformation.<sup>12</sup> The Israeli government worked for 50 years to discredit them and Israeli's were forbidden to read them. There must be something powerful to hide to result in these strictures. The truth is that even Jews have admitted that Israel is carrying out these Protocols to the letter.<sup>13</sup> It certainly cost Nilus; he was arrested by the Cheka (Russian secret police) and tortured. Somebody didn't want the Protocols let loose. When the Bolshevik Jews took over in 1917 one of the first things they did was to destroy all copies of Nilus' book. After this anyone in the Soviet Union possessing a copy of the Protocols was to be shot on sight. By seeking to destroy the Protocols, the Elite proves their fear. There cannot be any doubt that they contain information harmful to the Elite.

The 'Protocols of the learned elders of Zion' were certainly plagiarised,<sup>14</sup> the question is how far back do the original protocols go? They appear to go back as far as the antecedents of the Illuminati, which some say is as far back as the Knights Templar, and earlier.<sup>15</sup> The age-old protocols of the Elite, which were redrafted by Weishaupt, without doubt have long antiquity, because they are devilish in origin. Many of the principles found in this 'forgery' are, therefore, actually old Illuminati ideas. The essential principles to destabilise any society, with the purpose of generating a world empire, are satanic and go back to the beginning of time.

The fact is that we are seeing the realisation of these protocols in modern society.

- National governments are being made ineffective and are on a path to destruction.
- All religions are being corrupted (especially in the West) and are slowly being destroyed.
- Luciferianism is evidenced in the global Elite establishment.
- The family is gradually being destroyed.
- Socialism is seeking to abolish private property (NB the WEF, 'You will own nothing and be happy').
- The masses are being divided into opposing camps.
- Opposing sides in wars have been armed and financed to destroy nations and religion.

- Money and sex have been used to / blackmail high-level people in national seats of power and influence.
- Elite Marxist stooges have been placed in positions of power in colleges.
- The press and all media have been captured by five or six global corporations controlled by a very few Jewish oligarchs.
- Wars have weakened the empires of Britain and France, beginning in 1789.

Without doubt, Western society is being subverted by a secret globalist plan.

# **Freemasonry**

Freemasonry became closely aligned with the Illuminati after 1776. Robison wrote about the infiltration of masonry by these subversives in 1798 [see earlier]. Thus the higher levels of Freemasonry to this day are tied in to Elite objectives. This is illustrated by the writing of the Satanist Albert Pike, the most senior American Freemason of his day and leader of the Scottish Rite. Pike explains that the light in Freemasonry is the Cabala (Jewish occult mysticism)<sup>16</sup> and Lucifer.<sup>17</sup> He says, 'The Occult science of the Ancient Magi was concealed ... it is found ... in the Rites of the Highest Masonry.'<sup>18</sup>

Thus Elite factors are riddled with Freemasonic symbolism whether it is the dollar bill, the layout of Washington DC, the Great Seal, dates of key events, structures in Tel Aviv and so on.

Freemasons now occupy all the key seats of power in the UK. Indeed, most of the establishment institutions are riddled with Masons, such as the magistracy, the judiciary, the police force, the armed force officers, politicians, top corporatists, bankers, royalty, aristocracy and the secret service. In some areas promotion is impossible unless you are a Freemason.

Freemasons in society are key enablers of Elite plans.

#### B'nai Brith

This is the Jewish equivalent of Freemasonry and it has huge political influence in the US. However, it must be stated that Freemasonry itself is essentially Judaism for Gentiles. It forms a bridge between Gentiles and Jews on the basis of the common Luciferianism.<sup>19</sup>

#### 1798: Malthusianism

Thomas Robert Malthus [1766-1834] was an English economist and clergyman who pioneered the science of political economy. He is chiefly known for his theory, that the rate of increase of the population tends to be out of proportion to the increase of its means of subsistence. This was expressed in his *Essay on Population* (1798) demanding that controls on population are therefore necessary to prevent global catastrophe. In its milder form this suggests using sexual abstinence or birth control; its more radical expressions include genocide.

This theory has been debunked many times. In fact the world's population could fit entirely on Newfoundland Island shoulder to shoulder. The global population has increased dramatically since 1798 without catastrophic collapse. Increased populations have found better ways to improve food production. There is enough food for the entire planet, but

rich nations consume and waste food that deprives poorer nations. In fact, the world population is currently shrinking rather fast.

Despite this, the global Elite are Malthusians intent on planetary depopulation, as their many quotes confirm.

The most merciful thing that a family does to one of its infant members is to kill it. Margaret Sanger, founder of Planned Parenthood.

A total world population of 250-300 million people, a 95% decline from present levels would be ideal.

Ted Turner, (founder of CNN) interview in Audobon magazine.

In searching for a new enemy to unite us, we came up with the idea of pollution, the threat of global warming, water shortages, famine ... The real enemy, then, is humanity itself.

Alexander King, Bertrand Schneider, founder and Secretary respectively of the Club of Rome, *The First Global Revolution*, p104-105 (1991).

In order to stabilise world population, we must eliminate 350,000 people per day. J Cousteau, explorer and UNESCO courier (1991).

Cut the population by 90% and there aren't enough people left to do a great deal of ecological damage.

The purpose of US foreign policy in Africa is to reduce the population and preserve the mineral resources for America. [Sic.]

The present vast overpopulation, now far beyond the world carrying capacity, cannot be answered by future reductions in the birth rate due to contraception, sterilisation and abortion, but must be met in the present day by the reduction of numbers presently existing. This must be done by whatever means necessary.

The world today has 6.8 billion people. That's headed up to about 9 billion. Now if we do a really great job on new vaccines, health care, reproductive health services, we could lower that by, perhaps, 10-15%.

Bill Gates, *Ted Talk*, 2010. [15% of the current world population is over 1 billion people. Gates' vaccine programmes initially targeted poor people of Africa and India.]<sup>21</sup>

This Malthusianism explains many of the plans of the Elite which focus on depopulation.

# 1859: Evolutionary theory

Charles Darwin [1809–1882] published 'On the origin of species' in 1859, which marks the formal beginning of the acceptance of evolutionary theory of the origins of life even though theories about evolution had been published since the time of the ancient Greeks. Darwin's grandfather, Erasmus Darwin [1731–1802], had also speculated on this before Darwin's work. The French naturalist Jean Baptiste de Lamarck [1744–1829] was also an early proponent of organic evolution.<sup>22</sup>

The Elite supported and encouraged Darwin in order to institute massive changes in education and social engineering. Accepting evolution changes fundamental axioms. These include: that God created the universe; that God created human beings; that God gives mankind laws by which they should live; that God is sovereign in history; that man has obligations to do good to other people, etc. Instead these are replaced by 'the survival of the fittest' and 'life is red in tooth and claw'. Instead of following God's law to do good to fellow man, man is reduced to a beast status that is dominated by a selfish gene. There is no morality in evolution.

With the virtual universal acceptance of evolutionary theory, created through the education systems dominated by the Elite (see later), the way was set to make massive changes to society, culture, and ethics. One significant factor is that it promotes eugenics as a rational science.

#### 1908: The Rockefeller take-over of education

In a similar way that John D Rockefeller took over the medical profession, he also began to control education policy from 1908. This was initially devoted to capturing the teaching of history and corrupting it. This was because he understood the value of understanding history in order to better understand the actions of human beings in society and the end results of contemporary government policies. This was later extended to the humanities (liberal arts). By using grants to secure positions in key institutions for his placemen, Rockefeller gained control of the US education system and later of most Western educational establishments.

We can see the effect of this today. Kids learn virtually nothing about history in state schools. They are mainly taught modern history alone and especially WWII and the Holocaust, but little else. Before Rockefeller's influence came to bear, kids were taught ancient history, Classical history, the Celts, the Saxon invasions, Alfred the Great, Viking invasions, the Dark Ages, Muslim expansion, the Crusades, the Norman invasion, the Renaissance, the Plantagenets, the Reformation, the Tudors, the Elizabethan Age, the Stuarts, the Civil War and Commonwealth, the Restoration, the Glorious Revolution, the Enlightenment, the Georgian era, the Victorian period (including the Industrial Revolution

and the mercantile empire) and recent modern history. Modern kids are ignorant of all these matters.

# 1910: The Flexner Report (Allopathic medicine)

From 1901 John D Rockefeller sought to implement a plan to take over medicine by eliminating natural treatments and providing synthetic drugs formed from his Petro-Chemical industry. Thus, for example, synthetic aspirin [acetylierte Spirsäure 'acetylated salicylic acid'] replaced the tree bark from the plant genus Spiraea.

The Flexner Report led to the formal beginning of allopathic medicine in the US. After this Rockefeller was able, through providing finances, to get his placemen of all the key medical boards and universities and medical groups that he created. Gradually Rockefeller took over all medicine. This was then followed by the smearing and denouncing of all other medical systems (herbal doctors, naturopaths, homeopathy, nutritionists etc.) as quacks and eventually outlawing all other types of medical care that was not licensed to an Allopathic institution. People that successfully cured cancer were particularly targeted for attack; for example:

- Dr Royal Raymond Rife's Frequency Technology. This bacteriologist developed this treatment in the 1930s. It is a machine that targets disease-causing micro organisms by the use of frequencies. In 1934 he successfully cured 16 terminally ill cancer patients at the Scripps Institute in Southern California. A team of specialists confirmed his results. The Elite had to take action and Rife was ruined and his treatment shut down by the actions of Morris Fishbein, head of the Journal of the AMA
- Harry Hoxsey promoted a cancer treatment developed by his father (a veterinarian) which is a herbal mixture applied internally and topically. Dozens of patients were cured. In 1936 he developed the largest independent clinic in Dallas, Texas. The AMA attacked him viciously. Hoxsey sued the journalists and won but he was driven out of the country. A Hoxsey centre opened in Tijuana (Mexico) in 1963 and continues to operate with an 80% success rate (the chemotherapy success rate is 3%, less than the natural remission rate of 4%).
- Very recently, David Noakes treated cancer patients with GCMaff, a natural protein found in the body. His success rate was nearly 100%. He even treated patients for free if they could not afford it. He was smeared, hounded, and prosecuted. His laboratory removed; his finances confiscated. Even the judge in his English court trial admitted that he had cured cancer patients and was benevolently motivated. He went to prison. Then he was extradited to France where he was put into solitary confinement for months in a rotten French prison where he became weak and sick. Only by crowdfunding to get a good lawyer did he eventually gain a release on certain conditions. Nobody is allowed to be treated with GCMaff because it cures cancer.
- Whistleblowers have confirmed that the Rockefellers have numerous cures for cancer but their control of Allopathic medicine ensures that none of these is lawful. Moneyspinning (but useless)<sup>23</sup> oncology is continued.

We now have an Allopathic system whereby chronic disease is very poorly served by doctors. Specialisation ensures that nobody takes a holistic view of a patient's condition. Time constraints in the NHS ensures that no doctor has sufficient time to make a proper diagnosis. Regulatory bodies ensure that alternative treatments are dispelled despite being

able to cure people. Big Pharma not only engineers sicknesses (e.g. Autism from vaccines) but keeps people sick enough to be customers for drugs but not sick enough to die immediately. GPs have become dispensing centres for drugs whereby symptoms are treated but the cause is not discovered. Trauma centres and dialysis units work well but treatment of chronic conditions is very poor.

# 1918+ Development of a federal Europe

The proposal was for the elimination of nation states and the mongrelising of ethnic identities into a homogenised mixed race of Europeans.

# 1918: Proposal for a European league of nations

Founder of the Fiat empire, Giovanni Agnelli published 'European Federation or League of Nations' in 1918.

#### 1922: Pan Europa

The Austrian diplomat Count Richard Coudenhove Kalergi wrote 'Pan Europa' in 1922, which launched a federalist movement. Coudenhove was supported by the CFR. The initial objective was a merging of the French and German coal and steel industries and a customs union. Many leading figures supported this idea: Einstein, Picasso, Freud, Adenauer and others.

# 1925: Practical Idealism (the Kalergi Plan)

Coudenhove's 1925 book, 'Practical Idealism'<sup>24</sup> includes the Elite's strategy to 'turn the European into a mixed race of Asians and Negroes ruled over by the Jews'.<sup>25</sup> In 1922 he initiated the 'Pan-European Movement' to achieve the Elite strategy with the help of B'nai Brith, the Jewish version of Freemasonry and a Zionist supremacist lobby group. In 1932 his new edition of his book affirmed the disappearance of European national races and classes to create a 'Eurasian-Negroid race'; 'Europe will against its own will ... turn Europe into a mixed race of Asians and Negroes ... through this artificial selection process'.

This racist is highly esteemed by the EU, see for example the 'Coudenhove Kalergi Prize', given to heads of state in the EU for furthering the Elite supremacists aims of the EU. Prize-winners include Angela Merkel and Herman Van Rompuy.

This plan is the origin of the mass migration process, which is in full swing today.

Other factors in the development of the EU:

- The initial proposal of a united federal Europe was developed by Nazi SS officers as a means of continuing Nazi plans if Germany lost the war.
- Plans of the UK civil service. NB, 'The United States of Europe must be a political reality or it cannot be an economic one'. 26
- Jean Monnet: The founding father of the EU, Jean Monnet, rejected the idea of sovereign nations and believed in a federal Europe superstate. He planned to achieve this without the peoples of Europe realising it as the plan would take successive steps, each disguised by an economic purpose, all leading to federalism: pooling of Europe's coal and steel production, co-ordination of the atomic programmes, followed by the

Common Agricultural Policy, the Common Market and single currency. This is what happened.

- One of the proponents of a united Europe in the 30s was the Council on Foreign Relations sponsored by Rockefeller. It produced influential papers on 'Mechanisms for the economic integration of Europe'. European integration was actively promoted by Washington. In March 1947, influenced by the CFR and Coudenhove (now in America supported by the CFR), a resolution was put before Congress, 'Congress favours the creation of a United States of Europe'. The Elite sponsored a heavy media campaign in support; the New York Times editorial said, 'Europe must federate or perish'. <sup>28</sup>
- The American Committee of United Europe (ACUE) was formed as a covert means to convey CIA money from Elite groups (such as the Rockefeller Foundation) to promote a united Europe.<sup>29</sup> English recipients of this secret money included The Economist and Encounter journals. Between 1949 and 1960 \$4 million went to The European Movement. The CIA was the prime sponsor of the European ideal in the 50s.
- Churchill's speech in Zurich in 1946 where he advocated a 'United States of Europe'.
- In 1950 Monnet wrote a memorandum proposing that only through the creation of a dynamic Europe could future peace be secured; this involved setting up new supranational authorities (such as over the Ruhr). The French government accepted this and it became the 'Schuman Plan' (after French foreign minister Robert Schuman). Initially this plan was kept secret from the French Premier and other senior figures. US Secretary of State Dean Acheson had an informal meeting with Schuman and Monnet before it was presented to the French Cabinet.
- Out of this finally emerged the Treaty of Rome (1957) whereby the EEC formally came into being. There were many convoluted and deceitful issues both before this treaty and afterwards.

Thus it can be seen that the EU is the creation of the globalist Elite and eugenicists.

# 1919: Chatham House

Formerly the Royal Inst. of International Affairs (1919). This is a key centre of the Anglo-American Elite and sets crucial policy decisions.

#### 1919: The League of Nations

An association of countries established by the Treaty of Versailles purportedly to promote international co-operation and achieve international peace and security. Such a unit was a long-term plan of the Rothschilds. Originally the Congress of Vienna [1814–15] was supposed to evolve into a league of nations but this was scuppered by Russia (resulting in the Elite's hatred for Russia).

Versailles had been dominated by 80 Jews in the American contingent who manipulated the conditions that led to WWII. Thus the League was powerless to stop Italian, German, and Japanese expansionism leading to the Second World War, and was replaced by the United Nations in 1945. This became the prime vehicle for Rothschild and Rockefeller global ambitions.

#### 1921: The Council on Foreign Relations

This is the arm of the Elite dealing with, chiefly, American foreign policy. It controls the US State Department.

In the 1950s this was dominated by the Rockefellers and promoted their ideas about internationalism (Socialism / collectivism / state control).

# 1920s+: the development of Cultural Marxism

The origins of this lie chiefly with the Communist Antonio Gramsci [1891–1937]. He affirmed that the West had to be rid of Christianity by destroying all Christian culture in order to enable a Marxist revolution. The new battleground was culture not class war requiring a take-over of all institutions. Thus the family, schools, churches, media, entertainment, civic organisations, literature, science and history had to be corrupted by Marxists and transformed so that the proletariat could gain power. His theory of 'Cultural Hegemony' meant a cultural domination by the ruling class to be overcome by cultural revolution through gradual infiltration by Marxists.

Georg (György) Lukács [1885–1971] also realised that society could be demoralised and ruined if the family unit and sexual morality were eroded. Thus he implemented a policy of 'cultural terrorism' especially by targeting the minds of children through sex-education programmes in schools. This was perhaps the first explicit sexual education of kids encouraged towards sexual promiscuity. At the same time parents were terrorised and threatened. Children under this regime turned into delinquents, criminals, bullies, thieves, sex-predators, murderers and sociopaths. He also advocated the promiscuity and rebellion of women against patriarchy. This programme failed in Hungary as the people were outraged and Lukács fled when Romania invaded in 1919.

In 1923 Lukács met Felix Weil in Frankfurt where Lukács presented an alternative to Marx's economic revolution in favour of cultural revolution. This meeting led to the Institute for Social Research.

The Fabian Society was another hotbed for a stealth attack on Western society by slowly infiltrating institutions. The basis of the Fabian Society is social Darwinism<sup>30</sup> plus scientific socialism and, until the 1940s, its materialistic agenda could be clearly seen to be a totalitarian psychopathic plan. It proposes a cold, brutal, scientific control of human society by an unswerving ruthless government. It is atheistic, materialistic and scientific. Life is nothing more than Darwinian chemical functions. Humans have no soul or spirit. There is no God.

It was chiefly confined to elite, affluent, privileged people, like Tony Blair. Playwright George Bernard Shaw was a Fabian who openly advocated the development of gasses to kill racial stereotypes and dissident groups. Shaw also suggested a socialist system whereby people would sit in front of civil service committees to justify their existence; the panel would then determine whether the person was productive or needed to be murdered. HG Wells also advocated these principles and had a huge influence on conditioning society through putting them in his novels.<sup>31</sup> He considered that the 'base' of society was unfit to live due to intellectual incompetence and needed to be removed from society as 'congenital invalids'. Wells suggested this be done by mass starvation. Wells and the Fabians advocated that malformed children and disabled adults should be murdered, since they would drain the state's economy but could also contaminate the bloodline of the elite.

Blair and Gordon Brown were classic examples of the Cultural Marxist dialectic in their 'Third Way' New Labour policies, synthesising Left and Right wing economic strategies. New Labour did a great deal of damage to traditional cultural forms, much more than is usually recognised.

# The Frankfurt School

The foundation of Cultural Marxism is found in the Frankfurt School and its chief members. It was known formally as the Institute for Social Research founded in 1923 at the University of Frankfurt, Germany. Most of the key figures were radical Jews.

Herbert Marcuse [1898–1979] German-born American philosopher; co-founder of the Frankfurt School. He argued that revolutionary change can come only from alienated elites such as students. He called for a *Freudian 'polymorphic perversity*', eroding the idea of 'normal' sex. This helped to influence the 60s sexual revolution. With Fromm he promoted free love and identified sexual repression with capitalism, seeking to destroy the traditional concepts of family, parenthood and child-rearing. Gender, sex, family and marriage were social constructs to be deconstructed before liberation could happen.

The purpose was to solidify minorities like Blacks, women and homosexuals, as the coalition of victims that would undergird the new Marxist revolution. This led to the later movements of Black Power, Gay Rights, and Feminism and the centre of 60s antiestablishmentism. Marcuse is the important link between the original Frankfurt School ideas and the 60s counterculture, which originated modern political correctness. In his *Repressive Tolerance* (1965) he argued for toleration of everything on the Left and intolerance of everything on the Right.

Max Horkheimer [1895-1973] was director of the Frankfurt Institute for Social Research from 1930 to 1958 and a principal figure in the Frankfurt School of philosophy. He provided a Marxist analysis of modern industrial society and culture, 'interdisciplinary materialism'. These principles were collected into *Critical Theory* (1968). Other works include *Dialectic of the Enlightenment* (1947), written with his colleague Theodor Adorno. He stated, 'The evolution won't happen with guns, rather it will happen incrementally, year by year, generation by generation. We will gradually infiltrate their educational institutions and their political offices, transforming them slowly into Marxist entities as we move towards universal egalitarianism.'32

Theodor Adorno [1903–69] became the director of the Frankfurt School in 1958 but had teaching positions after 1938 in Princeton and Berkeley. He affirmed that Christianity, the family and capitalism are always prone to racism and fascism. Thus Christians are automatically fascist by definition. Traditional family values are racist and fascist. Psychologists need to retrain all those steeped in traditional culture.<sup>33</sup>

He also raged against beauty because it has become part of the ideology of advanced capitalist society, prettifying domination. Avant-garde music and art supposedly preserved the truth by capturing the reality of human suffering, seeing absolute oblivion as its goal, a message of despair. This spurred on the uglification now seen in society in art, architecture, town planning and graphics.

Saul D Alinsky [1909-1972] was the mentor of Hilary Clinton and Barack Obama; he is a devoted Cultural Marxist Jew. His 'Rules for Radicals' (1971) explains how to foment Marxist revolution through use of progressive grass roots community changes. It has been the textbook for the global elite in the last few decades.

#### Cultural Marxism led to:

- Postmodernism.
- Political Correctness. [To be normal one must adopt the new moral absolutes and throw away divine absolutes, thus embracing diversity, choice, sensitivity, sexual orientation, and toleration.]
- Multiculturalism. [Deleting Christianity and Christian principles as the foundation of society and accept anything at all as valid. Thus claiming that Hinduism, Homosexuality, Trans-sexualism, Islam, New Ageism, witchcraft etc. are valid British institutions.]
- Cultural Determinism. [This leads to 'Identity Politics', identifying everyone in a group instead of individuals.<sup>34</sup> This is based on Darwinism: man is without a spirit and is just an animal and is therefore to be identified by his social group (i.e. skin colour, sexual preferences etc.). So individualism, free will, moral accountability, submission to God are all denied.]

## Goals include:

- A worldwide totalitarian empire under Elite control.
- The destruction of Christianity.
- The ruination of Christian principles and morals in western society.
- Destruction of the family.
- Elimination of patriotism.
- Collectivisation and eradication of private property.
- Promotion of all kinds of evil in society; turning ethics upside down.

The two central objectives are: build a fascist world empire and destroy Christianity.

#### 1930s: The Eugenics Movement

Eugenics is the false science of improving a population by controlled breeding to increase the occurrence of desirable heritable characteristics. It originated with the British psychologist Francis Galton in 1883 as a method of improving the human race. The concept was widely discussed in Britain, the USA, and Europe in the late 19<sup>th</sup> and early 20<sup>th</sup> centuries but the principles fell into disfavour after the perversion of its doctrines by the Nazis.<sup>35</sup> The problem is that a privileged Elite decides who to treat as undesirable to be rooted out of society. Many eugenicists have targeted Black people for elimination.<sup>36</sup> Others have decided to eliminate: the disabled, the elderly, the intellectually weak, Gypsies, homosexuals and other races.

Many eugenicists are also Malthusians who seek, not only to improve humanity by selective breeding, but also to depopulate the planet of undesirables through any means possible. This includes: sterilisation via vaccines,<sup>37</sup> creating sickness,<sup>38</sup> reducing health

care by stealth,<sup>39</sup> creating epidemics,<sup>40</sup> starting wars,<sup>41</sup> etc. Eugenicists have openly stated that they have controlled all these things.<sup>42</sup>

Until WWII eugenics was immensely popular in America with multiple organisations committed to its objectives. Many organisations remained committed to it but hid behind a cover of something else, such as Planned Parenthood devised by the eugenicist Margaret Sanger. Bill Gates and his father are committed eugenicists and have spoken openly about the need for depopulation. There is a reason why the Covid vaccine, fully supported and sponsored by Gates, has killed millions of people.<sup>43</sup>

# 1930s: The Technocracy Movement

This is the proposed control of society by scientists and technological experts instead of politicians representing the people.

A centre of this was Columbia University in New York. Zbigniew Brzezinski and David Rockefeller collaborated with Technocrats and political scientists who were disillusioned with politicians and economists after the Great Depression. They planned a new energy-based economic system.

The project was held up by WWII. After the war, Brzezinski, Rockefeller and Klaus Schwab (all members of the Club of Rome, Trilateral Commission and the Bilderbergers) became the power base behind Agenda 2021, the Green New Deal and the Great Reset.

In 1970 Brzezinski wrote, 'Between Two Ages: America's role in the Technocratic era'. This led to the foundation of the WEF. Today the WEF fuses AI, gene editing, robotics and Transhumanism.

# 1945: The UN

The official story is that the United Nations is an international organisation, the successor to the League of Nations, to promote international peace, security, and co-operation. In reality it is an instrument of the global Elite cabal, chiefly the Rockefellers and the Rothschilds, to promote universal acceptance of their original policies for a new world order; a global collectivist state.

Thus everything is not as it seems. For example, UNESCO (ostensibly an agency of the United Nations to promote the exchange of information, ideas, and culture) is behind the current adoption of extreme sexual education policies for young children in British schools.

Two of the key strategies of the Rockefellers (see '1956') to achieve global control are: 1) the use of pandemics to control health policy and population control; 2) the use of a climate catastrophe (climate change alarmism) to gain control of global resources. These are currently being worked out via the UN (and thus all nations) through the creation of the IPCC to establish false data and policies on climate change based on modelling, and the

WHO to gain global control over health responses of every nation to pandemics and epidemics. [See Maurice Strong.]

# 1948-1953: The Kinsey Reports

These reports are two books on human sexual behaviour written by Alfred Kinsey and others: *Sexual behaviour in the human male* (1948) and *Sexual behaviour in the human female* (1953). Kinsey founded the Kinsey Institute for Research in Sex, Gender and Reproduction (the Kinsey Institute).

These challenged the prevailing moral beliefs and discussed taboo subjects.

Many experts challenged the validity of Kinsey's methods and cherry picking of data. There were also claims that some data was gathered from child molesters. Kinsey admitted to interviewing paedophiles and hiding their identity. Flaws in sampling methods proved that Kinsey overestimated the rate of homosexual sex. He also estimated that 8 million Americans indulged in bestiality. His assertions include:

- Up to 37% of adults had committed homosexual acts.
- 7% of men and 13% of women in the population are homosexual. The commonly accepted figure is between 1-2%; less for females. A robust study for the CDC showed no more than 1.6% of Americans are homosexual.
- 30% experienced homosexual oral sex.
- 94% had committed adultery.
- 11% of married men had participated in anal sodomy.
- 50% liked being bitten in sex.
- 50% of farm boys had committed bestiality.
- Children are sexual from birth. Babies can achieve sexual climax many times in an hour. An 11-month old baby had ten orgasms in an hour. Another had 14 in 38 minutes. This posits child molestation in the study.

Remember that this is in the very conservative early 1950s after WWII. It is just not credible.

Kinsey himself was a deeply disturbed person who was a fornicator and paedophile. His so-called research was accepted as fact and led to the massive moral changes on sexuality and particularly of homosexuality that developed in the 1960s (the sexual revolution; the permissive society).

# 1947: The Tavistock Institute

Formed in 1947 and based in London, it is a think-tank to combine research in the social sciences with professional practice. It deals with problems in organisational development, institution building and change in all public sectors. It pioneers work in behavioural science to control people; i.e. brainwashing techniques and crowd control methods using psychology.

The CIA has always worked on guidelines set up by the Tavistock Institute. Tavistock Institute has developed such power in the US that no one achieves prominence in any field unless he has been trained in behavioural science at Tavistock or one of its subsidiaries. The drug revolution (LSD) was a Tavistock programme run by the CIA. Common Purpose is a Tavistock Institute project.

# 1948-1952: Ancel Keys' reports

Ancel Benjamin Keys [1904-2004] was an American physiologist who wrote reports on diet and health. The reports of Keys were heavily criticised as being flawed using cherry picked data and bad methodology, especially the *Seven Countries* study. Nations like France, Switzerland and Chile that had a high fat consumption but low instances of heart disease were left out.

He theorised that replacing saturated fat from meat with polyunsaturated fat reduces coronary heart disease and that there is a link between dietary cholesterol and heart disease. The health organisations run by the Elite corroborated this, which led to the complete change in processed food available in supermarkets and the demonisation of eating meat, especially red meat.

In fact, eating meat is very healthy and saturated fat is not only good for you it is essential. Certain vitamins can only be processed in the body by using saturated fat. Your brain is made from mostly saturated fat and water. Note how the healthiest tribes in history ate lots of saturated fat, such as the native Innuits. Compare that to the unhealthy modern American eating polyunsaturated fats from seed oils.

As the world followed the advice of Keys, chronic disease has skyrocketed globally as refined carbohydrates and cancer-causing polyunsaturated fats replaced meat.

To eradicate saturated fat, processed food became available using High Fructose Corn Syrup to elevate the taste. Good saturated fat was replaced by sugar in processed foods. Polyunsaturated spreads were introduced to replace healthy butter, but these were made from seed oils, which are very unhealthy. In other words, healthy food was replaced by unhealthy food. This was a key Elite objective; to make populations unhealthy and candidates for Allopathic drugs.

# 1952-54: The Reece Report (Communist collectivism by stealth)

The Special Committee of the House of Representatives to Investigate Tax Exempt Foundations (1953-1954). Chairman: B Carroll Reece (Tennessee). Based on the investigations of lawyer Norman Dodd [1899-1987] and his team.

This established that the charitable foundations (Carnegie, Guggenheim, Rockefeller, Ford, and later RAND) were secretly conspiring to bring about a Communist, collectivist system in America that was compatible with that of the USSR. '[We] Use our grant-making power so to alter life in the United States so it can be comfortably merged with the Soviet Union' (Rowan Gaither, president of the Ford Foundation). This was treason. It was the use of vast sums of money to pervert traditional values and re-engineer the social system.

Lawyer Catherine Casey was able to examine the huge Carnegie minutes from 1908. The new CEO, Joseph Johnson, obviously did not know what was in them. These minutes demonstrated plans to change the thinking of the American people towards Socialism and to get America into a war – which was the fastest way to implement social change. Control of the State Department was essential. When the US entered WWI, a message was sent to President Wilson to discourage an early end to the war.

After the war, the key objective was to alter the education system and especially American history. Grants were given to historians to write a new slant on history. Schools that accepted these textbooks received grants from Guggenheim and Carnegie foundations. The foundations then captured the American Historical Association. In 1934 a report was published stating that the day of the individual in the U.S. was over; the future would be characterised by collectivism and state power.

The report showed that the foundations promoted:

- Centralised research.
- Big universities.
- Moral relativism.
- Internationalism.
- Social engineering.

The foundations picked FD Roosevelt as president and between 1933-1936 America underwent a social revolution. The economic welfare of the American people was transferred to the executive branch of the federal government.

The most heavily funded schools and universities (e.g. Columbia, Harvard, Chicago, and Berkeley) were filled with Cultural Marxist Jews from the Frankfurt School. These sought to:

- Direct education towards an internationalist view.
- Discourage traditions.
- Transform education into an instrument for social change.
- Train people to provide advice to the excessive branch of federal government.
- Separate education from its local community and traditions.
- Change the curricula to undermine traditional values.
- Push education to serve political agendas.

By 1999 polls revealed that 72% of professors were identified as liberals (Socialists in US terms), four times the population as a whole. Over time observation and testing has shown that education has been dumbed-down.

After WWII these policies were pushed on a worldwide basis; especially by the Ford Foundation. In Britain the rot in education began to set in after the 1960s; spurred on by the failed Labour experiment of Comprehensive Schools and attacks on Grammar Schools.

Under the US Constitution, the Library of Congress must supply citizens with copies of government reports, but for 70 years it has failed to supply copies of this one to requests for it. Website links have also failed.

#### 1954: The Bilderberger Group

Co-founders were political advisor Joseph Retinger and Prince Bernhard of the Netherlands in 1954 This secretive group of Elite figures plays a leading role in the development of Elite policies which are then implemented by others. Its object is to remove independence from all countries and allow the old aristocracies to rule despotically behind the consensus of the UN.

For instance, the creation of the EU was determined by the Bilderbergers. Leaked documents from 1955 show that they were planning to create the EU and a central European currency decades before they came into existence. The initial iteration of the EU came into being shortly afterwards as the EEC,<sup>44</sup> set up by the Treaties of Rome in March 1957. The EU arrived in 1993.

It is difficult to assess how far this group controls world events because their minutes are kept hidden and tight security prevents interlopers gaining access to their annual meetings. We only have the information provided by whistleblowers.

# The Club of the Isles

A European cartel centred in the City of London and headed by the House of Windsor. This controls every aspect of the global economy, banks, insurance, big pharma, raw materials, factories, stock markets etc. It comprises the ranks of bankers, financiers and money oligarchs that control Britain and control over £10 trillion of assets. It is a financial British Empire that controls companies such as, Royal Dutch Shell, Imperial Chemical Industries, Lloyds of London, Unilever, Lonrho, Rio Tinto Zinc and Anglo American DeBeers and scores of others. It dominates the world supply of diamonds, gold, petroleum and other vital raw materials, which funds its geopolitical agenda.

It was named after the 'Prince of the Isles', Edward Albert (King Edward VII) who orchestrated the Crimean War, the Opium Wars and WWI to consolidate Britain as the prime European monarchy.

Note the 1995 Royal Institute for International Affairs (Chatham House) Discussion Paper 60, Economic Opportunities for Britain and the Commonwealth' by Katherine West. This claimed that the Commonwealth nations had the power to dominate every regional economic bloc. Commonwealth nations have the largest voting bloc in the UN.

The City of London controls global markets including raw materials extraction, finance, insurance, transportation, food production and industry. James Adams, in a London Times article, admitted that the banking houses in the City launder \$400 billion per annum in illegal narcotics profits. The Club of the Isles also is the leading controller of global organised crime and has been since its use of Giuseppe Mazzini.<sup>45</sup>

It is leading to a post industrial new world where only 5% of the most intelligent people will flourish and the rest of society will suffer, as Lord William Rees-Mogg wrote. The Elite provide the escape of drugs, media, sex, rock music counterculture to mollify the masses by distraction. This is Huxley's 'concentration camp of the mind'. This was later supplemented by the Green activist movement, which has become a pagan religion and a massive distraction while creating pawns for Elite objectives.

Note also King Charles III's heavy promotion of climate alarmism, the UN's sustainability goals and the WEF.

# 1956: The Rockefeller Brothers Fund

This is where the origins of Green sustainability and climate change alarmism began. This is a new chapter in eugenics initiatives.

A special project was initiated by Nelson Rockefeller funded by the Rockefeller Brothers Fund. This addressed the problems of the day with ideas to fix them. Henry Kissinger (ex-Harvard and CFR contributor) was the project manager along with David Rockefeller. The idea was to shape a new world order, working out every detail to establish this: spiritual, economic, political and social. The keys were science and technology (Technocracy) to establish their aims.

The Rockefellers identified four priorities:

- Control of energy after the end of oil.
- Control of the global economy after an economic collapse.
- Control of planetary resources.
- Control of populations through medicine and pandemics.

Control of global resources was to be achieved through creating Green (environmental) alarmism. This would be based upon false ideas about a climate catastrophe. Through utilising this fear, control of global resources could be achieved.

Initially the threat was claimed to be an impending ice age because there had been some cold winters in the early 60s (notably 1962-3) and 70s but then temperatures began to rise and global warming became the slogan. As warming stopped the slogan was changed to 'climate change' (something that happens naturally all the time).

Population control would be achieved through controlling health through toxic medications, hazardous scans and debilitating treatments; implementing environmental poisons and initiating pandemics with the resultant toxic vaccines.

Note the work of Maurice Strong (Rockefeller placeman) in the UN and sub groups to develop sustainability programmes that were really developments in the Rockefeller plan. ['Sustainability programmes' equals global Elite strategies for population control.]

Kissinger was also the director of Harvard's international seminar to establish a better understanding amongst key people who would be leaders of various nations and organisations. This was funded by Rockefeller and Ford. The CIA was also involved. Klaus Schwab was a student of this. He was selected to further the Rockefeller's internationalism.

#### 1960: The JASONS

This is a secret society of scientists, founded in 1960, used by the Elite to formulate research and reports into Elite projects. It is separate from official governmental authority but funded by DARPA and others.

Some of its projects include: the foundation of the global warming scam (report: 'The long term impact of atmospheric carbon dioxide on climate').

# 1961: The Atlantic Council

A globalist think tank focused on international affairs founded in 1961 that is based in Washington DC. It is militaristic and staffed with CIA, generals, CEOs, and hawkish politicians. It is closely connected to NATO. It supported al-Qaeda terrorists in Syria and Libya. It has called Washington to prepare for WWIII with Russia and China. It has also promoted Internet censorship.

[Note: I am aware of a number of other secretive groups that contribute to Elite plans for world domination, such as: OTO, The Council for Inclusive Capitalism, the Project for a New American century, Skull and Bones society etc. but these are subsidiary.]

# 1968: The Club of Rome

Formed by Aurelio Peccei, an Italian industrialist and Alexander King, Director General for scientific affairs at the OECD (Organisation for Economic Co-operation and Development).

An umbrella organisation comprising the Black Nobility dynasties and Anglo-American bankers. The goal is world government through manipulating economic recessions and depressions. It forms strategies for furtherance of a new global order. For example it developed the original strategy for Green sustainability issues (climate change, net-zero) as a means of achieving Elite objectives in 1972. It even proposed a 'one-child' policy for Western nations. Most of its conclusions have been thoroughly dismissed by economic professionals.

# The Limits to Growth, 1972

This report based on computer simulations averred that economic growth would not continue due to resource depletion. It predicted food shortages beginning in 2023. [See later.]

## The First Global Revolution, 1991

The follow up to Limits to Growth. In this book the Club of Rome admits to inventing the climate change alarmism of today in order to unite the world in globalism; 'Our future depends on a global society' (p150). Note:

In searching for a common enemy against whom we can unite, we came up with the idea that pollution, the threat of global warming, water shortages, famine and the like, would fit the bill. In their totality and their interactions these phenomena do constitute a common threat which must be confronted by everyone together. .... All these dangers are caused by human intervention, and it is only through changed attitudes and behaviour that they can be overcome. The real enemy then is humanity itself.

The First Global Revolution, p75, 115.

In general the report affirms that the problem on the Earth is mankind; humans are bad for the planet.

The common enemy of humanity is man.

P115.

This report was later followed by the 1992 Rio Earth Summit to develop strategies to push this idea.

#### 20 March 1969: Dr Richard Day speech

Rockefeller insider Dr Richard Day's speech, on 20 March 1969, to the Pittsburgh division of the American Medical Association; about 80 doctors.<sup>46</sup>

Day was a member and medical director of Planned Parenthood and was an eugenicist.

Day's off the cuff remarks (which he had insisted were not recorded or that people took notes) outlined secretive globalist plans for a totalitarian new world order to be implemented (originally) within 30 years.

# Predicted items include:47

#### **EUGENICS**

- Population control.
- Eliminating swathes of humanity.

- Permission required to have babies.
- Abortion.
- Euthanasia.

#### MEDICAL CARE

- Less access to medical care for unemployed and retired people.
- Elimination of private doctors.
- New diseases that are difficult to diagnose and were untreatable (N.B. AIDS followed).
- Suppressing cancer treatments (he admitted that the Rockefeller Foundation had a number of effective cancer cures).
- Man-made pathogens; AIDS being one.
- Promoting ill-health; making society sick; undermining medicine.
- Make health care expensive.
- Promoting spurious pharmaceutical medications; suppressing effective treatments.

## PERSECUTION OF OLD PEOPLE

- Make the world hostile to old people (e.g. small fonts on forms; DNR notices).
- Less access to medical care.

#### FOOD CONTROL

- Ready meals to be available in supermarkets. Make people lazy.
- Rationing of food. Food controlled.
- Forbidding people to grow their own food. (The UK has just made it a requirement to register private chickens.)

#### **SEXUALITY**

- Separating reproduction from sex.
- Sex education as a tool of world government.
- Blurring the difference between male and female; no gender.
- Encouraging homosexuality.
- Encouraging experimentation.

#### **FAMILY ISSUES**

- Diminishing of marriage.
- Making both parents work; state control of children.
- Increasing commuting time.

#### **MOBILITY**

• Travel initially made cheaper to encourage families to separate. But then it will be made expensive to hinder mobility.

#### SOCIAL CONTROL

- Terrorism to engineer global government and social control.
- Implants to be used for surveillance.
- Eliminate home ownership.
- Houses to become too expensive for young people.
- Monitoring of people through technology like television.
- Social engineering.
- Illicit drug use to be encouraged.
- Running shoes to be made more glamorous.

- ID cards required for all travel. ID later to be implemented inside the skin.
- Build more prisons.
- America to lose its manufacturing base.
- Discourage national pride and patriotism.
- Control the weather; notably rainfall.
- Western society to be shaken to its foundations.
- Continual changes to society to create instability.

#### RELIGION

- Introduction of a one-world religion.
- The Bible to be altered and corrupted.
- Corruption of religions to begin with Roman Catholicism.

#### **FINANCE**

- Eliminate cash; electronic transitions.
- All purchases monitored.
- Eventually there would be one credit card, later to be a skin implant.
- Inflation as a tool of control.
- Savings curtailed to eliminate wealth. If you save too much your wages would be reduced.
- Credit encouraged to foster debt.

#### **MORALITY**

- Increased sexuality.
- Promotion of homosexuality.
- Availability of pornography.

# **EDUCATION**

- Education as indoctrination. Kids won't learn anything.
- Scientific research falsified to promote agendas.

# 1970: Klaus Schwab founds the European Economic Forum (forerunner to the WEF).

This was a sub-group of Rockefeller interests mentored by Rockefeller agent Henry Kissinger. The point was to slowly implement Rockefeller internationalist / Socialist plans in various nations. It involved politicians, academics and leaders of corporations.

# 1971: Maurice Strong

Rockefeller insider Strong commissioned a report entitled, *Only One Earth: the care and maintenance of a small planet* (1971), to further the Rockefeller plans for controlling global resources. The report was actually written by Barbara Ward and Rene Dubos. This was a powerful catalyst in developing the Green sustainability agenda. This led to the first UN conference on the environment in Stockholm in 1972 and the establishment of the UN Environment Programme (UNEP) led by Strong. He then convened the first international group meeting on climate change.

Strong mentored Schwab. Strong and Ward were also involved with the Club of Rome. The agenda was based on the fact that the planet needed a global management to take care of it.

In 1983 Strong was one of the commissioners of the World Commission on Environment and Development set up as an independent body by the UN.

Various UN assignments led by Strong resulted in the Rio Earth Summit in 1992. This was the culmination of Rockefeller plans for global control as summarised in the resultant Agenda 2021 document. After this Strong continued to take action to implement Agenda 2021, such as establishing the Earth Council, the Earth Charter Commission, the World Resources Institute and the International Institute for Sustainable Development, plus other bodies (even advising the WWF). He was also a director of the World Economic Forum.

Strong was, therefore, a very important catalyst in implementing Rockefeller plans for global control of natural resources and population control.

## 1972: Club of Rome 'Limits to Growth' document

Book by Donella H Meadows, Dennis L Meadows, Jorgen Randers and William W Behrens III. A report for the Club of Rome's project on the predicament of mankind. The foreward was written by U Thant, UN Secretary General, who opined that mankind had ten years left to survive unless changes were made, such as to curb global population.

- The Earth can't sustain the human population by 2100.
- Food shortages and famines.
- Reduction of the Western standard of living. Western prosperity reaches a peak about 2020 and then begins to fall.
- Collapse of supply chains.
- Collapse of natural resources.

A television documentary was made about this in 1973, which demonstrated, with primitive computer simulation images, a food collapse in 2023 onwards. This is now underway.

#### 1973: the oil crisis

Arab countries started an oil embargo; the price of oil increased 300%. Arab leaders claimed that Kissinger had been involved in inciting the embargo.

This gave support to the warnings from the Club of Rome about global resources. Warnings about a rise in oil prices had been issued before the oil crisis. This gave rise to the Trilateral Commission calling for a new international economic order to better manage the world. This involved getting rid of national sovereignty and introducing technocracy.

# 1973: The Trilateral Commission.

Is a vehicle for multinational consolidation of the commercial and banking interests forming co-operation between the East and the West. It was founded by David Rockefeller. In 2021 there were 400 members. It was initially organised by Zbigniew Brzezinski (a Rockefeller advisor) to promote globalism.

It has published a book criticising democracy and championing elites ('The Crisis of Democracy', 1975) stating that the public needs to be reduced to apathy and obedience. Senator Barry Goldwater wrote that it was trying to seize the four centres of power: political, monetary, intellectual and ecclesiastical to create global economic power superior to national governments. It is thus a prime source of global Elite strategies and planning.

# 1976: The Harold Wallace Rosenthal interview, 'The Hidden Tyranny'

This was whistle-blowing Jew who worked in the US government who said,
Through these vehicles [monopoly of the movie industry, the radio networks and
television media, newspapers, periodicals, technical journals & school materials] we

could mould public opinion to suit our own purposes. The people are only stupid pigs that grunt and squeal the chants we give them, whether they be truth or lies. ... We control their cry and hue. The only thing that exists is an unthinking majority and unthinking they will remain, as long as their escape from our rigorous service is the opiate of our entertainment industry. By controlling industry we have become the taskmasters and the people the slaves. The television and movie industries furnish the necessary temporary distraction. These programmes are carefully designed to appeal to the sensuous emotions, never to the logical thinking. Because of this the people are programmed to respond according to our dictates, not according to reason.<sup>48</sup>

Rosenthal also gives an example of manipulating public opinion in order to weaken the nation:

Through religion we have gained complete control of society, government and economics. No law is ever passed except its merits have previously been taught from the pulpits. An example of this is race equality which led to integration and ultimately to mongrelisation. The gullible clergy in one breath instruct their parishioners that we are a special, chosen people while in another breath proclaim all races are the same. Their inconsistency is never discovered. So we Jews enjoy a special place in society while all other races are reduced to a racial equality. It is for this reason that we authored the equality hoax, thereby reducing all to a lower level. ... Their religion is only another channel through which we can direct the power of our propaganda. These religious puppets' stupidity is only exceeded by their cowardice, for they are ruled easily.

In summary he stated that the aims of Jewish tyranny was:

- Monopolise entertainment, radio, television, newspapers, periodicals, technical journals & school materials. Create distractions.
- Mould public opinion.
- Control industry.
- Control religion.
- Control society, government and economics.
- Use race equality to lead to integration and ultimately to mongrelisation.
- Jews enjoy a special place in society while all other races are reduced to a racial equality.
- Direct the power of propaganda.

# 1987: The WEF

The EEF becomes the WEF. Maurice Strong was initially involved. It promoted the idea of technocracy but included sustainability and climate change.

#### 1988: The UN IPCC

The Intergovernmental Panel on Climate Change. This was the solidification of the UN's plan for Green sustainability objectives (establishing Communist collectivisation as per Agenda 2030 and earlier Rockefeller plans) by centring on global warming. The central claim is anthropogenic climate change based on CO2 emissions. It was established by the UN Environment Programme and the World Meteorological Organisation.

After it became clear that the planet was not significantly warming up the UN changed the slogan to 'Climate Change' (as if a changing climate is something unusual).

The central feature of IPCC policy was the production of predicted climate models based upon computer simulations. These have proved to be utterly unscientific and hopeless in their predictions. In fact, much of the so-called science is deeply flawed using incorrect

data, such as ground-based temperature readings subject to urban heat distortion. Nevertheless, the UN keeps pumping out Armageddon scenarios of doom to scare populations with utter lies.

The central dogma is the claim that carbon dioxide is a dangerous greenhouse gas that causes the planet to heat up. This then drives all the social and energy policies seeking to revolutionise society at astronomical cost resulting in inefficiency. However, the claim is fake because there is no scientific basis to prove that CO2 causes a rise in temperature; none whatsoever. In fact, ice-core and other soil samples show that CO2 rises after the planet warms up not before. Apart from all that, CO2 is a wonderful molecule that greens the Earth, increases oxygen and enlivens the planet. We need far more of it; the current level of 420ppm is historically very low. Lower than about 180ppm and the world dies.

The plans of the IPCC, and associated bodies, are vital in order to continue the sustainability agenda that seeks to impose total control over people (you cannot drive, can't have a gas cooker, can't have gas central heating, can't eat meat, can't fly etc.).

# 1989: Common Purpose

This supposed charity is an organisation devoted to leadership training of key people in society. It teaches the common purpose of its central ideology, which is Socialism, globalism and collectivism. It works as an arm of the Elite, ostensibly linked to the EU and is supported by the government through VAT taxes; though it claims to be independent and non-aligned. It currently has 110,000 alumni.

It is an indoctrination technique that uses various psychological methods to brainwash trainees. These go on to become politicians, judges, magistrates, social leaders, educationalists, leaders of the police, and councils etc. Thus, for example, the former head of the Metropolitan Police was a Common Purpose graduate. You will see posters regarding Common Purpose on school notice-boards, which supposed to be dedicated to school issues not outside bodies, because it is now embedded within the school system.

What this does is produce homogeneity of thinking and purpose amongst social leaders, all committed to the same Communist task of transforming society.

# 1991: Cairo population conference

- Sustainable development.
- Population reduction.
- Abortion.
- Condoms. Family planning.
- Euthanasia.
- Wars.
- Famine.

# 1992: Agenda 2021 / Agenda 2030

This developed from the UN Rio Eco Summit and was signed off by 178 nations; virtually the whole world. It is a plan to cover the 21<sup>st</sup> century with various implementation dates; a key one being 2030. It was heavily influenced by Maurice Strong and the Rockefellers.

#### Predicted items include:

- Gaia (mother Earth) worship.
- The environment is superior to mankind.
- Focus on sustainable development and biodiversity.

- Danger of global warming leading to desertification.
- 15-minute cities. Local populations restricted to zones.
- Elimination of small farms, concentration into Big Aggro.
- Control of all food supplies.
- Categorisation and cataloguing of everything in life, control of everything, taxing everything (water, nature, human bodies, air etc.).
- Relocation of rural dwellers into cities.
- Large metropolis cities built to house humanity.
- Control of housing.
- Rural areas listed as forbidden zones. Only the Federal government and military allowed into them.
- Huge arterial highways linking big cities in narrow corridors across the countryside.
- Global warming used as a stick. Sustainability used as a carrot.

This is a plan for Communist centralisation and collectivisation.

# 1995: Copenhagen Social Summit

- Empowerment of the UN.
- Loss of national sovereignty.
- Global taxation.
- Global army.
- National arms and forces reduction.

# 1995: Beijing Fourth Women's Conference

- Empowerment.
- Women as producers.
- Family dependency ratio.
- ERA.
- Rights of the child.

#### 1996: Istanbul Habitat II

- UN operating on local level of government.
- PPP. [Public-Private Partnerships.]
- Loss of personal property rights.
- Biodiversity restricts residential choice.

# 2002: The Great Transition Initiative

This was a continuation of the 1956 Rockefeller brothers agenda based on 'build back better'.

This involved 'The New Paradigm' to create the best future scenario and avoid hazardous scenarios. Their plan would supposedly create 'a new planetary society' (Collectivism). [See 2022 The Common Agenda.]

The new paradigm could be achieved by a global crisis such as a global pandemic. This would be followed by a world court, a world bank, a world regulatory authority and a totalitarian state.

The WEF had been active in mentoring prospective leaders of nations in the young global leaders initiative. These leaders include: Jacinda Arden, Tony Blair, Angela Merkel, Barrosso, Gordon Brown, Justin Trudeau, Macron etc.

#### 2005: the 2020 initiative

The young global leaders identified (using modelling) the current global trends, risks and opportunities and formulated a vision of the world and strategies to deal with them by 2020. It created task forces to achieve their ambitions. It was later renamed the 2030 initiative.

# 2006: The first WEF global risks report

The risk of a pandemic flu was a key global risk that had to be countered. Misinformation needed to be countered.

# 2006: The RAND corporation report 'Global Revolution 2020'

This predicted the need for digital ID chips being required in products and people. by 2020.

# 2008: The global economic crisis

This became a trigger to reshape the world system. The WEF held its first global summit in Dubai. Its theme was to reshape the world for the needs of the 21<sup>st</sup> century. A global brain trust would be necessary (a la Rockefeller original plans).

# 2009: Shaping the post crisis world (WEF)

Newly founded Global Agenda Council. National governments were irrelevant and a new Marshall plan was necessary.

The G20 became the premier council to discuss global problems and a new economic order

# 2010: Scenarios for the Future and International Development

A Rockefeller report on future global plans and technological development. It included the 'Lock-Step' document on pandemics.

# 2011: WEF's Grass Roots initiative

Young global shapers community which has since grown to 479 hubs around the world with 14,000 members. Mission: to empower young people to shape the global agenda in local communities. Led by Klaus Schwab.

# 2015: WEF transformed

The WEF changed into an international organisation for public / private partnerships and shaping the future.

#### Goals of the WEF

- End national GDP.
- End of capitalism.
- Green taxation.
- Commodification of children. Treating children as an economic product. This is based upon continual surveillance with data on children being placed on the blockchain with digital profiles. Each child is evaluated and identified as to their likely use in society and then certain ones are invested in by Elite financial entrepreneurs. Children become financial products in the stock market.
- Schools to be privatised and funded by banks. Distance learning (Zoom) for better control by isolation.
- The Blockchain is used as a tool for domination.
- Impact investing.
- Human capital bonds.
- Stakeholder (i.e. the above).

• Surveillance: proposals include ID chips in vaccines, in pills and even in clothes.

# 2015: UN Agenda 2030

With 17 sustainable development goals.

# 2015: The Fourth Industrial Revolution - Technocracy

Popularised by Klaus Schwab (WEF). This is not just improved technological efficiency but a paradigm shift in industrial capitalism. It is the change from the digital age (1990s to early 2000s) to embedded connectivity and augmented social reality.

- Growth of AI.
- Gene editing, geonomics.
- Advanced robotics.
- Transhumanism. Joining humans to digital platforms.
- SMART technology.
- Internet of Things, Internet of Bodies. Connectivity of everything.

This is a plan to reshape humanity and the world by technocracy. The forum's shapers include the leading corporations in the world, such as Bill Gates and the Welcome Trust.

The WEF's board of trustees includes all the important world banks, Blackrock, etc.

# 2019: Union of power structures

The WEF formally united with the United Nations. This is a powerful alliance to establish the globalist agenda. It links Agenda 2030 with the Fourth Industrial Revolution.

The top managers of global governance are the UN, the WEF and the G20 leaders; these control the planet (but there are bodies above them).

The WEF's Young Global Leaders programme conditioned certain prospective people, grooming them for state leadership. This included: Angela Merkel, Justin Trudeau, Emmanuel Macron, Jacinda Ardern and many more. Schwab openly boasted that the WEF had infiltrated most Western governments and in some cases (like Canada and Argentina) over 50% of the cabinet were a protégé of the WEF.

#### 2019: UN initiated the Decade of Action

Greta Thunberg was the useful idiot to be the key presenter. The slogan was, 'unite behind the science'. Climate change was decided as the key vehicle to achieve objectives. A climate emergency was declared as a threat to biodiversity and health. Global corporations, national governments and NGOs united behind this framework for action. The alliance would then implement draconian measures.

#### 2020: ID 2020

The plan to provide a digital identity passport for everybody on Earth to enable continual governmental surveillance through inserted microchips. The cover was the supposed enabling of poor people in the developing world to access state welfare.

# June 2020: WEF, The Great Reset - Corporatocracy & Technocracy

An economic plan designed by the Elite under the cover of the Covid crisis. Launched by a video with Prince Charles. Followed by a book by Klaus Schwab. The claimed priority was sustainable development (cf. Agenda 2030). It dominated the Davos conference in May 2021 and in 2022.

- Development of a 'stakeholder economy'; this is code for corporatocracy. The union of corporations and national government. This is the actual Mussolini definition of Fascism.
- Building in a more resilient, equitable and sustainable manner requires ESG (environmental, social and governmental) metrics.
- The Fourth Industrial Revolution.

This calls for deregulation, combined with a policy role for unrepresentative, unelected corporations overriding government institutions. The Great Reset is the development of corporatocracy.

GDP is a thing of the past to be replaced by a new economy based upon Green taxes and data driven surveillance using impact investing and human capital bonds linked to the block chain (i.e. social credit system). Schwab calls this 'stakeholder capitalism' where humanity is the sole commodity. Human data is already being harvested but will become the basis of financial markets. Covid lockdowns were planned to crash economies to bring about total control to enable the new economic system (reset).

Human interactions will be abolished (arts, live theatre, music festivals, live concerts) to be replaced by virtual reality programmes. Travel will be abolished; replaced by virtual reality. The human will be merged with digital systems (Internet of Bodies).

Schwab's two books (*The Great Reset* and *The Fourth Industrial Revolution*) represent the key developments in the new Elite rebuilding of society through Corporatocracy and Technocracy.

# 2022 The Common Agenda

A further continuation of the Rockefeller strategies for world domination.

This was a combination of a unified approach by the UN and the WEF. The objective was a digital world; a digital society based upon a digital ID. It was a 'new social contract' for a 'planetary society'. Note that in Nigeria this is being implemented in digital IDs being required to obtain water. A digital ID card is necessary to get water pumps to release water. Eventually digital IDs will be necessary to get anything, including food and energy.

This is the perfect control system. Dissidents will be unable to obtain money (via CBDCs) food or water. It secures global compliance to a totalitarian government.

Global governance is based on several ranks of power:

Global Level (The UN, G20, The WEF).
Regional Level (the EU etc.).
National Level.
Local level.

#### 2022: United Nations, International technical guidance on sexual education

This includes the UNESCO Education Centre and The Global Education 2030 Agenda. It lays out the UN's 'Comprehensive sexuality education' (CSE).

A few statements from the long Agenda document include:

- Sexual education does not increase sexual activity.
- Sexual education has positive effects.

- There are many kinds of families.
- As children grow up they develop their own values which may differ from their parents.
- Kids must question social and cultural norms that impact sexual behaviour.
- It's important to know the difference between biological sex and gender.
- Affirmation of homosexuality; Homophobia and Transphobia are harmful.
- Gender stereotypes lead to violence. Affirmation of Transgenderism.
- [For 5-8-year olds] People show love to each other by touching and intimacy, including sexual behaviour. Normalising sexual intimacy for 5-year olds.
- Graphic discussion of sexual intercourse with images.
- Discussion about sex toys.

These are policies arising from the Elite to train schools how to pervert children. Much of the base data emanates from the wicked Kinsey Institute that originated with a paedophile fornicator. This even encourages children to avoid teenage pregnancy by having anal sex.

The policies being currently enacted, for example in Welsh schools, is using graphic images and language to teach children as young as four details about sexuality that are way above their age level. They are taught about masturbation, homosexuality, permissive sex (fornication), anal sex, birth control methods, and transgenderism. This is without parental consent. Groups consisting of pupil's mothers are trying to fight this in the courts but it is ubiquitous because it stems from the UN.

#### 2023: the rollout of CBDCs

The IMF and various central banks announced the beginning of the rollout of CBDCs. Many organisations demanded the end of paper money.

# Example: climate alarmism.

This is the most important policy in our age because it is driving the extremes of Net-Zero policies, which will destroy civilisation in its present form of prosperity based on personal liberty and cheap energy. The cost of implementation is in the scores of trillions and it deprives society of most of its comforts (cars, meat, cookers, central heating, flight, local mobility etc.). Is this accidental or incompetent reaction to scientific realities? No it was planned for decades.

- 1956: The Rockefeller Brothers Fund. Sets out the basic principles of using climate catastrophes to produce climate change policies in order to control society.
- 1969: Secret plans and goals of the Elite. These were exposed by Richard Day (connected to the Rockefellers) in 1969. The climate change alarmism nonsense fully complies with these plans for social and economic revolution.
- 1972: The Green policy originated in reports by the Club of Rome from 1968, which were published in 1972. This was openly admitted as an idea to achieve global aims in a 1991 publication. [See Club of Rome earlier.]
- 1988: The UN IPCC. This is a unit to provide fake data to blame humans for climate catastrophes. This continually makes false predictions based on computer simulations.
- 1992: The Rio Earth Summit. This gained support of all nations by treaty to implement the proposals of the Club of Rome. Implementation to be at international, national, regional and local levels (e.g. 15-minute cities is a local level objective).
- 1992: The UN Agenda 2021 (later 2030). This laid out strategies to implement the Rio sustainability agenda for 100 years, which would result in the enslavement of humanity under a sustainable agenda ruled over by elites.
- 1997: Rio+5. A UN session to appraise the status of Agenda 2021. It did observe increasing globalisation but uneven progress elsewhere. A new General Assembly resolution (S-19/2) promised further action.
- 2002: The Rockefeller's 'The Great Transition Initiative' document. Established 'The New Paradigm' to achieve a planetary society.
- 2002: Earth Summit 2002 (Rio+10), the Johannesburg Plan, affirmed commitment to Agenda 2021.
- 2002: The UN also agreed to Agenda 21 for Culture (at Porto Alegre, Brazil): changing culture as a sub-programme to Agenda 2021.
- 2012: Rio+20. UN re-affirmed commitment to Agenda 2021.
- 2015: Sustainable Development Summit. Re-asserts all of the goals of Agenda 2021 incorporated into 17 objectives.

- 2015: Klaus Schwab The 4<sup>th</sup> Industrial Revolution plus 2020: The Great Reset. This was a WEF reworking and updating of Agenda 2021. The 17 sustainable goals of Agenda 2030 are included in the Great Reset.
- 2017: The sustainable development goals of Agenda 2021 were renamed Agenda 2030 at an UN General Assembly meeting where specific targets are set for each goal. And indicators to measure progress were activated. Goal 13 involves Climate Action to combat climate change; i.e. regulating emissions, renewable energy schemes etc.
- 2019: The Strategic Partnership Framework. This was a combined strategy between the WEF (Schwab) and the UN (Antonio Guterres) to accelerate the goals of Agenda 2021/2030.
- 2020: Covid crisis. Schwab stated that the 'pandemic' provided an opportunity to bring about social change that will 'reengineer the whole of society' according to Agenda 2030 goals.
- 2022: The Common Agenda of the WEF / UN to bring in a new social contract for a planetary society based on digital technology and control.

So climate alarmism originated, at least, in plans laid out in 1956 and was redeveloped and repackaged at various times after this. The goal is a plan to enslave humanity and ensure global totalitarian control by the Elite in a reconstructed dystopian society.

# The plans behind the Covid crisis

# 1999+: Patents on coronavirus begin to appear49

Every aspect of the coronavirus and Covid vaccines is patented; including the spike protein. Gain of function research initiated in America. Key players are: Tony Fauci, Ralph Baric, Peter Daszak, EcoHealth Alliance, Chapel Hill North Carolina University, and DARPA. After 2015 gain of function research transferred to Wuhan but was still financed by the US. The vaccine programme is controlled by the US military, not health agencies.

	long before any outbreak in Asia.  The key elements of the pandemic virus were engineered (and can be modified) using gene sequencing technology (turning a computer code into a pathogen). These elements include: 1) the ACE receptor, 2) ACE-2 binding domain <sup>52</sup> and 3) the S1 spike protein. This technology was funded by the US taxpayer, supposedly, to use the harness coronavirus as a vector to distribute the HIV vaccine.
Late 2002 to 2003	Alleged outbreak of SARS in Asia. [The coronavirus group had been endemic in nature for thousands of years. This new form was manipulated.]
April 2003	The CDC files for a patent for the entire SARS gene sequence and for a series of patents covering means of detection, including the PCR test. The CDC gained scientific and message control of SARS by owning the virus and its detection.  It is illegal to patent a naturally occurring substance.

2017	Moderna was already working on a Covid vaccine. [Testimony of Romanian MEP
	Christian Terhes in the EU Parliament.]
2018	The patent on the recombinant nature of the lung-targeting pathogen was transferred from the University of North Carolina to the NIH. But the NIH had already funded this and had rights to it. This is illegal under US law. The reason why this had to be done is that there was a typographical error in the first filing. This was the necessary patent to develop the Covid vaccine.
March 2019	Four Moderna patent filings were amended (failed and revitalised) to include the term 'a deliberate release of respiratory pathogen'.
September 2019	'A world at Risk', published by the WHO (Global Preparedess Monitoring Board), says there must be co-ordinated preparedness for a global release of a coronavirus pathogen, including public relations, crowd control and a universal vaccine.
November 2019	Researchers at the University of North Carolina at Chapel Hill, who collaborated with the Wuhan Institute on gain of function research, along with the NIAID began the sequencing of a spike protein vaccine before the Wuhan outbreak (with Moderna). <b>The Covid vaccine was in process before the official outbreak began.</b> The spike protein RNA sequence is a computer simulation that has been patented for many years. This complete genome was a fabrication. The sequence did not come from any virus, let alone a new virus. It was obtained from crude broncho-alveoli fluid samples from a single patient that contained billions of genetic fragments; not from purified viral particles. A computer was used to analyse sequences and potential combinations and combine them into a potential genome. Circular reasoning was used to claim a new virus: take a sample from a patient, claim it is new Covid, identify genetic sequences from this patient, which must then be Covid.
2 January 2020	[Chinese publication referenced by the CDC and the Lancet] 41 patients are confirmed as having a laboratory novel n-Cov coronavirus. But this was not supposedly isolated until the following week. They claimed a new pathogen not yet confirmed as having existed.
23 January 2020	Christian Drosten and his team published their study explaining the diagnostic discovery of Covid-19 by a PCR test. <sup>54</sup> This protocol was 'designed in absence of available virus isolates or of orignal patient specimens'. The test was based on downloaded computer genetic sequences from uploaded gene banks released by China on 3 January 2020. Still SARS-Cov-2 had not been proved to actually exist. They generated a hypothetical sequence from previously detected sequences and then created primers to target short sequences within that sequence. There was no explanation as to what these primers might react to. There was no virus involved at any stage. This dodgy paper was

The first edition appeared on the WHO website nine days before the paper was accepted for publication. This test was then rolled out to the world as the prime test for Covid.  There are multpile technical issues with the Drosten paper, which have been condemned by scientists all over the world and a retraction was demanded very soon after publication. Essentially, Drosten just created a new PCR protocol that could be used to detect the new virus with no proof of its veracity. The Drosten paper has nothing to do with clinical application – how well the test works in the field. We don't know the PCR's diagnostic specificity. No nation in the world using PCR tests can provide any evidence that it can diagnose Covid (though they say it can). As the inventor of the PCR test (Kary Mullis) explained, you can find anything you want with the PCR if you manipulate it by amplification. Every drop of saliva contains many millions of bacteria and other cells. A single mammalian cell has 360,000 mRNA molecules.  Fauci's emails show Peter Daszak stating that a cover story was needed to distance him and the Chinese from the virus.

They then matched tissue samples with the Chinese published sequence and claimed a connection; but at no point has anyone isolated a new virus. The electron computer images simply show vesicles <sup>55</sup> or viral-like particles. But these particles must be shown to cause infection and that infection must be Covid-19 (one of Koch's postulates). No one did this.

30 March 2021	Peter Daszak's WHO investigation into the origins of Covid is widely dismissed as a whitewash.
June 2021	The Lancet appointed Peter Daszak (head of the EcoHealth Alliance) to lead an enquiry into the Covid origins. He championed the animals to humans origin and called a lab origin a conspiracy theory. Yet Daszak has received millions from the US to investigate and modify coronaviruses himself; and works closely with Tony Fauci. In June 2021 Daszak finally recused himself without any explanation.

#### 2016: PCR test kits

- There must be co-ordinated preparedness for a global release of a coronavirus pathogen, including public relations, crowd control and a universal vaccine.
- Dedicate resources and finance to preparedness as an integral part of national security.
- Commit to sustainable development goals.
- Appoint a high-level preparedness co-ordinator to lead government approaches, including regular simulation exercises.
- Involve the private sector.
- Develop vaccines.
- Non-pharmaceutical interventions (lockdowns, masking, social distancing).
- Sharing genome sequences.
- Increase WHO contributions.
- Greater control of the WHO.

#### 18 October 2019: EVENT 201

THE CORONAVIRUS HIGH-LEVEL PANDEMIC SIMULATION. It was organised by the Bill and Melinda Gates Foundation with the World Economic Forum. It was held at the Pierre Hotel in New York City under the auspices of Johns Hopkins University's Centre for Health Security.

#### Predicted items include:

- The sudden appearance of a new coronavirus that caused respiratory illness. Effects which varied from mild flu-like symptoms to severe pneumonia. The virus was modelled on SARS.

# **Conclusion regarding the Covid crisis**

All the historically novel things that happened during the Covid crisis were planned and described in various simulations, fiction, presentations and reports going back decades.

The gravity of this must be understood. The West had epidemic preparedness protocols in place based upon long experience and high level epidemiological inputs. These included protecting the vulnerable (focused protection), prophylactics where available, stepping up hospital services, and so forth – all common sense. Society would continue as normal as far as possible.

This all changed in 2020. The former protocols were overturned and entirely novel, and non-sensible, programmes were brought in. Every country in the world brought in the same programmes – despite being medically unsound. This was because there was a schedule of these new policies that had been prepared and planned for years or even decades by a high-level group of bankers, NGOs, corporatists, geo-politicians and controlling interests. Of this there is no doubt; their programmes were published. The old, sane epidemiological protocols were thrown out and the new programmes (as simulated and modelled) were brought in. National governments implemented the plans of these Elite people. The Covid crisis was completely planned in advance.

Commentators were shocked when reports emerged in April 2023 that China had been working on a Covid vaccine in 2019 before the pandemic. Yet Pfizer was also working on a Covid vaccine in 2019 but Moderna had been working on a Covid vaccine in 2017. When confronted in an EU hearing by this the CEO of Moderna was speechless. No one in the western media reported on this bombshell news proving that there was a Covid conspiracy going back years.

# Proof that nations are controlled by a higher power intent on secret agendas to destroy society

There is a specific current example that proves that there is a global secret agenda to implement certain plans in every nation that are shocking, insane and wicked. This is the Net-Zero agenda. This means that total greenhouse gas emissions (including methane and nitrogen from farms) must be less than their removal (e.g. planting trees). Absolute zero (as in the FIRES report) is the only way to secure real Net-Zero because capture and removal of gases technology is absent.

# Non-representative

This plan has no democratic sanction. No one voted for it. Not one has explained what it means to the electorate. It is being rolled out now but most people have no clue what it means for them.

# It denies prime government ethics

The chief reason for government is to secure the well being of the national community. Internal security is the number one priority. Net-Zero will destroy national security. It will lead to food insecurity; energy insecurity, employment insecurity and much more. It will restrict human freedoms. In fact, it will lead to vastly increased poverty, starvation and depopulation. It is literally insane.

# This is governmental policy

This is not supposition or hyperbole, it is the actual budgeted formal policy of the government (and all Western governments in sync). It is best demonstrated in the UK FIRES collaboration document: 'Absolute Zero' (November 2019). This report, produced by Oxford, Cambridge, Strathclyde, Nottingham and Bath Universities plus Imperial College London for the government, reveals multiple shocking proposals to make life miserable. These are the repercussions of the Climate Change Act, which requires the public to stop doing anything that causes emissions regardless of energy source. We can summarise some provisions as follows:

This timetable will now be advanced because the government proposed a new target date in law in April 2021 to slash emissions by 78% by 2035.

# So key points:

- All airports shut by 2050. Foreign holidays will be terminated.
- Beef and lamb forbidden by 2050. Greatly reduced up to 2030. This will mean taxation.
- No new petrol / diesel cars by 2030. Only small electric cars by 2050.
- No new buildings by 2050. Therefore a massive homes crisis.
- Steel and cement phased out.
- All trade using aircraft and ships to cease. Imports vastly reduced and more costly.
- Everything will become far more expensive due to reduced supply and increased travel costs.

Students currently entering secondary education should, therefore, not be trained as airline pilots, astronauts, or beef farmers for example. Are they being taught this?

Another document explaining changes to society to achieve Absolute Zero is, 'The Future of urban consumption in a 1.5°C world', C40 Cities, Headline Report (June 2019). This was produced by the University of Leeds, ARUP and C40 Cities. It claims that the activities of humans cause more greenhouse gas emissions than was previously thought based on data produced by the IPCC. This avers that an average temperature rise of 1.5°C above preindustrial levels is the number to preserve a hospitable global temperature. It centres on consumption-based emissions, as opposed to production-based emissions.

This is similar to the FIRES document (cut transport, reduce aviation, reduce meat etc.), but adds that the number of new clothes purchased each year must be reduced to three by 2050. Household waste must be reduced.

C40 Cities is a global network of 100 urban mayors committed to enabling the aims of Agenda 2030. The group is currently under the chairmanship of Sadiq Khan (Metropolitan London mayor).

#### It's a fantasy

Despite these goals being pure fantasy, the government is serious and demanding that the public takes action. People will very soon be forced (unless there is a U-turn) to get rid of gas cookers and wood burners.

However, there are key problems (as I have explained many times):

- Battery storage for when the wind does not blow is out of the question. Even if there were enough lithium and cobalt reserves in the world the cost would be greater than national GDP.
- EV cars are out of the question: they are too expensive, inefficient and dangerous (the batteries explode).

- There is insufficient electrical energy in the grid to cater for all the requirements of car batteries, cookers, heating and trains.
- There will never be an electric aeroplane or cargo ship due to battery weight constraints (even if there were enough raw materials, which there are not).
- Wind and solar are already proving to be far too inefficient for a national power supply. They are also not Green, too expensive and turbines kill millions of animals.

All in all the policies are stupid and not at all environmentally friendly. Furthermore they would demolish modern life as we know it and destroy centuries of increasing prosperity. Our children will have a very bleak future. Rising prosperity in the last 200 years has been mainly due to cheap and widespread energy availability. Under Net-Zero, cheap energy will be a thing of the past.

So, this global strategy is insane and nobody voted for it or desires it; yet the government is determined to bring this in. This proves that the government is following instructions from a higher authority and is not representative of the people. Unwanted policies are top down; desired domestic policies are ignored (such as low taxation, less bureaucracy, genuine policing, ethical jurisprudence etc.).

# **Another pointer**

During the Covid hoax multiple new policies were enacted to fight the virus which were new, untested and counter to epidemiology. These included facemasks, PCR tests, social restrictions, lockdowns and test and trace projects. Almost every nation of Earth brought these measures in despite their novelty and pointlessness. This shows co-ordination by a higher power than national governments.

# Assertions by eminent people that there is a conspiracy to rule the world<sup>57</sup>

It was not my intention to doubt that, the doctrines of the Illuminati, and principles of Jacobinism had not spread in the Unites States. On the contrary, no one is more truly satisfied of this fact than I am. The idea that I meant to convey, was, that I did not believe that the Lodges of Freemasons in this country had, as societies, endeavoured to propagate the diabolical tenets of the first or pernicious principles of the latter (if they are acceptable of separation). Thus the global elite were operating a hidden influence as far back as the late 1700s in America.


**Descent of regulations**

# The spiritual dimension

It behoves Christians to obey the Bible as the living Word of God applied by the Holy Spirit. Thus explanations of events in the world, as explained or predicted by the Bible, should be accepted as a true explanation of what is going on.

I have explained many times that the Bible clearly shows that the Lord allows the Devil to gather mankind into a world empire at the end. This is the fulness of the sin of mankind in preparation for the final harvest of sinners unto condemnation resulting in the cleansing of the world and its restoration for saints in fellowship with God on Earth.

This final world empire, the culmination of Satan's efforts in previous world empires, is a totalitarian, fascist world government fully committed to evil. It represents the very reverse of all of God's principles for human beings – the antithesis of God's law.

Now Satan and his demons can do nothing in material terms without the co-operation of men. Thus the final global kingdom is established through Satan indwelling powerful men who are directed to build this empire in accordance with the plans of Satan. It is interesting that as many people begin to understand the real basis of what is occurring in the world and that a cabal controls these things according to a plan, they begin to be interested in the Bible and Christianity. Delingpole is one of these. He now calls himself a Christian and honours Christ, delighting in the Psalms; though I fear that he, and many others, are only in the professing, seeking stage and are not yet regenerated believers. However, it is a beginning.

# Why do so few people understand this?

#### It is obfuscated

Well firstly, the Elite has done much to try to keep it all secret. Whistleblowers have been smeared, shut down and even killed. Exposes have been denied as conspiracy theories. Education has been skewed to make kids accept the establishment propaganda. Governments censor alternative views.

# The example of Toby Young

Let us take Toby Young as an example, since he represents many.

Toby stands for free speech and social liberty. He is a good family man and a champion of good causes, which he articulates as a guest on many news programmes and panel shows. Why, then, does Toby believe that the ills in society are not planned at all, that there is no Elite cabal in control and that stupid, incompetent, careerist politicians just 'cock things up' to promote political gain? Let's analyse this.

#### The reasons could be:

- *He is just stupid.* This is not the case. He had an Oxford education when universities meant something. His behaviour demonstrates that he is very intelligent.
- *He does it from malice.* I discount this as I believe that he is of good character.
- He is a hidden supporter of the Elite (a shill). Some have accused him of this. I do not share this view. He has opposed Elite strategies numerous times, despite not understanding the Elite origins.
- He is motivated by money. This would make him a 'presstitute'; he sells his media services to make a fortune going against his conscience. I do not buy this. Though he has a certain affluence (he has expensive taste in alcohol and food, can afford to take his whole family on holiday to expensive Iceland, goes on shoots at aristocratic mansions etc.) he is not rich. He is a middle-class man living in Acton (London). He also functions as a commentator opposing evils in society.
- *He is ignorant*. This could be the answer. Why is he ignorant?

Why is Toby ignorant? How come he can correctly analyse many complex situations but cannot see Elite cabal control.

- *He is stupid*. Not the case.
- *He is lazy*. Not true. He is, in fact, a workaholic.

- *He has not been exposed to the truth.* Not true. James Delingpole explains it to him constantly. He chooses to not believe it.
- He is distracted and does not investigate conspiracy theories properly. I think this is partly the cause. He works very hard on his various jobs and invests no time in proper research on Elite plans.
- He is wedded to a certain mindset. This is the probable main cause. He derives his personal security from believing in a liberal society based on historic British principles not understanding that these have been overrun. He still has trust in British institutions hoping that good sense can still prevail, such as the education system, parliamentary democracy, the monarchy, central banks, the justice system or the official regulators. He has specific issues with these on occasion but he does not believe that there is an overarching systemic problem controlled by globalist forces. In fact, all these systems have been corrupted according to a long-term Cultural Marxist plan. It would break his mindset if he admitted that all these causes are already lost (which they are).

In the case of ordinary people, the most obvious answer is that they do not bother to research the issue properly because they are so distracted by television, social media, sports, hobbies, clubbing, coping with life etc.

# Conclusion

If one had enough time, one could investigate all the negative innovations that are being introduced into Western society and show that they emanate from a prior plan by subgroups of the global Elite, such as the UN, the WEF, the Club of Rome, the WHO, the Bank for International Settlements and other institutions.

The central origin point for all these novel destructive strategies is the mind of Satan working through human proxies. The purpose is to help bring about the construction of a totalitarian world empire that is completely submitted to the Devil.

There is a centralised plan behind all the negative agendas going on in society.

# Select glossary

#### 5G

The new generation of wireless telecommunication connectivity. It uses high-level, non-ionising EMF radiation that is dangerous to all life-forms. 5G antennae have been illegally installed all over Britain during the lockdowns, which had had no medical risk assessments. 5G is vital in order to implement the Internet of Things, the essential plank of Technocracy.

#### **CBDCs**

Central Bank Digital Currency. This is a system of currency based on the blockchain that is entirely digital with no external money (banknotes). When rolled out it will enable governments to have full control over the population by restricting one's access to their own money for non-compliance with state demands.

## Climate Change alarmism

This is the promotion of the dangers of a climate catastrophe caused by the activity of human beings. This, in turn, is based upon anthropogenic climate change claims.

The basis is that human CO<sub>2</sub> emissions cause global temperature increases. This has never been established by any science at all. In fact, proven science shows that CO<sub>2</sub> rises follow global increases in temperature.

Furthermore, CO2 is highly beneficial to life on Earth. It is a vital molecule that feeds plants, which then produce oxygen. Too little and the Earth dies. Earth currently has far less CO2 than at many previous historical points.

Global temperatures have repeatedly been far higher in the past and these were times of global prosperity, such as the Medieval Warm period.

Humans produce comparatively little CO2. Far more CO2 is produced by termites or a single volcano eruption.

#### Collectivisation

To organise on the basis of ownership by the people or the state, abolishing private ownership or involvement.

This has been a tool of Socialist regimes, often enforced violently, such as by Stalin in the USSR (1929-33) and Mao in China (1953+).

In the current globalist plan, collectivisation is the eradication of private property and the central planning and control of everything by the state.

#### **Global Elite**

A secret cabal of powerful super-rich people that control every aspect of the world, from finance to raw materials, to stock markets, to food supply, to dominating national governments, to hegemony of energy supplies, to controlling the media and so on. These people are top bankers (e.g. the Rothschilds), corporatists (e.g. the Rockefellers), leaders of investment companies (e.g. Blackrock, Vanguard), senior politicians (e.g. Bill Clinton, GW Bush), senior political activists (e.g. Klaus Schwab), senior philanthropists (e.g. Bill Gates), senior NGO leaders (e.g. George Soros), senior religious leaders (e.g. the pope, the Jesuits, the Dalai Lama) and historic bloodline aristocrats (e.g. King Charles III, Prince Bernhardt).

The top layer is a restricted number of a few people including the Rothschilds and Rockefellers but also other secretive people. [You can see the superiority of Jacob Rothschild over King Charles in a photograph of Jacob scowling at Charles and pushing a finger onto his chest. Charles is clearly disconcerted.]

Other terms: the Deep State or Shadow Government (though these chiefly refer to the hidden secretive governments in nations). The Illuminati (though this chiefly refers to an early incarnation that existed in the late 18<sup>th</sup> century in Bavaria and elsewhere). The Black Nobility (though this chiefly refers to the aristocratic bloodlines that dominated Europe for centuries). The Cabal, literally meaning a secret political group that pursues plans by underhand methods. The people in power see themselves as the Elite, hence the preferred term for them.

Many of the Elite are Luciferian in predisposition. However, their backgrounds vary: they are Talmudic Jews, Kabbalists, Freemasons, Jesuits, Gnostics, Theosophists, witches and many more. Luciferianism is common to most of these.

#### **Globalism**

The attempt to gather all power structures into a centralised global administration. Some use the term to imply the plans of the global Elite.

#### Social credit

A system of social control that already exists in China. Obedience to government diktats is necessary to gain access to your own money and to social services, such as getting food. Failure to comply results in social and financial restrictions.

# Sustainability goals

This is the Elite ruse to install social controls and social engineering based upon the claim to be taking better care of the planet. Environmentalism becomes the basis of population control, de-industrialisation, a new digital economy, social restrictions, and totalitarianism.

The methods used in sustainability projects are utterly hypocritical and false. For example, closing down clean nuclear power stations and instead burning biomass pellets which come from chopping down ancient trees in Virginia and shipping the processed pellets to Britain for burning, thus creating excessive CO2 emissions.

17 sustainability goals are the central plank of Agenda 2030.

# **Technocracy**

Rule of the state by scientists and experts instead of by monarchs, politicians and economists. Technology dominates every aspect of life through new digital systems based on 5G connectivity.

This is connected to the Internet of Things and the Internet of Bodies whereby everything is interconnected by digital signals and controlled by a central computer system.

#### **Transhumanism**

The transformation of human beings into cyborgs by the implantation of nano-digital devices through vaccines and other methods. This enables the transmission of personal data (e.g. medical condition) and the importation of external commands received through 5G technology. The ultimate aim is the full control and surveillance of people by the ability to exercise control over the mind, will and mood. Such technology already exists but has not been distributed widely yet.

#### **UBI**

Universal Basic Income. A key part of the social credit system. Everybody relies upon a state handout. No one earns an individual salary. It is a part of the new feudal system to be introduced.

When they give birth we will inject poisons into the blood of their children and convince them its for their help.

When their teeth decay we will fill them with metals that will kill their mind and steal their future.

When their ability to learn has been affected, we will create medicine that will make them sicker and cause other diseases for which we will create yet more medicine.

They will grow depressed, slow and obese, and when they come to us for help, we will give them more poison.

We will focus their attention toward money and material goods so that they may never connect with their inner self. We will distract them with fornication, external pleasure and games so they may never be one with the oneness of it all.

#### Gentiles are to be killed

Even the best of the Goyim should all be killed.77

If a Jew murders a goy there will be no death penalty.78

If a Jew killed a goy he is not responsible.79

Kill the Goyim by any means possible.80

Everyone who sheds the blood of the impious (non-Jews) is as acceptable to God as he who offers a sacrifice to God.<sup>81</sup>

Extermination of the Christians is a necessary sacrifice.82

The best of women – is filled with witchcraft.89

# World domination by Jews

That the Jewish nation is the only nation selected by God, while all the remaining ones are contemptible and hateful. That all property of other nations belongs to the Jewish nation, which consequently is entitled to seize upon it without any scruples.<sup>90</sup>

## Talmud is anti-Torah

There is greater stringency in respect to the teachings of the Scribes than in respect to the Torah ... so that Biblical law may be transgressed.<sup>91</sup>

## Summary of Talmudic goals

- Destroy Christianity and all religion except Talmudism.
- Destroy all nations and replace with Jewish internationalism.
- Subdue all people as slaves to a ruling Jewish cabal.

Gentiles are] shells or husks of evil  $\dots$  waste matter  $\dots$  bad blood  $\dots$  foul waters  $\dots$  dross  $\dots$  dregs  $\dots$  the root of evil. $^{98}$ 

It is a religious duty, however, to eradicate Jewish traitors, minim (Christians) and apikorsim (apostate) and to cause them to descend to the pit of destruction.<sup>99</sup>

It is a duty to exterminate them with one's own hands. ... Such as Jesus of Nazareth and his pupils ... may the name of the wicked rot.<sup>100</sup>

One million Arabs are not worth a Jewish fingernail. 101

Our most important and ambitious program. One that will finally and totally remove from existence the impediments of our absolute control of this earth. I speak of the death of the white race. The complete removal of all means of reproduction of the so-called Aryan race, Men, we now control the destiny of this race. It is now time to make sure the white race becomes extinct through miscegenation and having a virtually zero birth rate. ... It is worth any price to annihilate the next generation of White children. We want every White father to feel the sting of having their children marry coloured mates and produce biracial children. ... We will deal with the less co-operative Goyim by murder and imprisonment. Finally, we will see the end of the White race. Impressionable White children will have their minds moulded into the agents of their own destruction. <sup>102</sup>

The key to solving the social problems of our age is to abolish the white race. <sup>103</sup> It is the duty of every Jew to exterminate infidels with one's own hands – infidels such as the pupils of Jesus of Nazareth. <sup>104</sup>

The goal for which we have striven so concertedly for 3,000 years is at last within our reach. ... Within five years, this program will achieve its objective, the Third World War, which will surpass in destruction all previous contests ... This war will end our struggle against the [white race]. ... The last generation of white children is now being born. Our Control Commissions will, in the interests of peace and wiping out interracial tensions, forbid the whites to mate with whites. The white women must cohabit with members of the dark races and the white men with black women, Thus the white race will disappear. ... Our most dangerous enemy will become only a memory. ... We [Jews] will embark upon an era of ten thousand years of peace and plenty, the Pax Judaica, and our race will rule undisputed over the earth. Our superior intelligence will easily enable us to retain mastery over a world of dark peoples.

Since the Jews are the highest and most cultured people on earth, the Jews have a right to subordinate the rest of mankind and to be the masters of the earth. 106

The Jewish people as a whole will become its own messiah. It will attain world domination by the dissolution of other races  $\dots$  Thus will the promise of the Talmud be fulfilled. <sup>107</sup>

With Gentiles ... they need to die, but God will give them longevity. Why? Imagine that one's donkey would die, they'd lose their money. ... Why are Gentiles needed? They will work, they will plough, they will reap; and we will sit like an effendi and eat.<sup>108</sup>

The difference between a Jewish soul and souls of non-Jews – all of them in all different levels – is greater and deeper than the difference between a human soul and the souls of cattle. 109

All non-Jews are evil by nature. The Jews are the crown of creation, the non-Jews are the scum of the earth. 110

We have to recognise that Jewish blood and the blood of a goy are not the same thing. Every law that is based on equating goys and Jews is completely unacceptable.<sup>111</sup>

According to the Talmud, one may kill any Gentile. 112

A Jew who kills a non-Jew is exempt from judgment and has not violated the prohibition of murder. 113

# **Comparison: The Protocols**

The aristocracy, which enjoyed by law the labour of the workers, was interested in seeing that the workers were well fed, healthy and strong. We are interested in just the opposite – in the diminution, the killing out of the Goyim.<sup>114</sup>

# **Example in action: Jewish control of 10 million murders**

... The way of that conditioning would be the one used in Central Europe to condition Nazi minds. There the circulation of an ideology began in the public schools, began with a small child, which is where **we** will have to begin and educate not only our own people but the peoples of the world and **we** will have to have five generations of the consciousness concept of democratic co-operation before **we** can create a world capable of mental and emotional tolerance.

- Destruction of all religions.
- Establishment of Luciferianism.

## **Goals of the Jacobins**
